CODE OF CONDUCT & DISCIPLINE

The Students are expected to maintain a high standard of discipline

- 1. The following are deemed to be acts of indiscipline:
- l. Disregard of order and instructions of the members of the institute staff
- II. Disregard of institute/hostel rules, orders and notices.
- III. Improper Usage/Damage of institute properly
- W. Irregular attendance and unauthorized absence from classes and hostel
- V. Lack of punctuality, payment of all dues and other matter where date and time for any dues, function or obligation are prescribed
- VI. Persistent neglect of studies and assignments.
- VII. Habitual illness.
- VIII. Failure to wear the prescribed uniform & shoes during working hours,
- IX. Failure to produce identity card on demand by as staff, warden etc, at any time within the institute/hostel premises
- X. Recourse to false or fraudulent statement or acts.
- XI. Recourse to unfair means in tests & examinations.
- XII. Possession of stolen properties, committing theft, engaging in consumption of drugs & liquor, gambling and involving/abetting in any unlawful activities.
- XIII. Un sportsman like behavior in indoor and outdoor games.
- XIV. Noisy, boisterous, disorderly and disrespectful behavior inside and outside the institute/hostel
- XV. Ragging in any form inside and outside the institute/Hostel Premises
- XVI. Taking part in demonstration, strikes in and outside the institute/Hostel Premises
- XVII. Failure to report Indiscipline cases to the institute authorities.
- 2. Studentshall be responsible for the machinery/equipment allotted to them and ensure their proper utilization and upkeep of machinery.
- 3. Student shall be responsible for all books, apparel us, tools, instruments, materials, etc, issued to them.
- 4. Student who are awarded stipend shall execute a bond
- 5. Students shall observe all safety precautions. The Institute is not responsible for accidents of whatever nature in the institute, hostel, workshop, laboratory, and playground and at any other place.
- 6. No society, association or club shall be formed by the students without the prior permission of the Centre-in-charge.
- 7. No meeting shall be convened and no person shall be invited to address any meeting in the institute/hostel premises without the prior permission of the Centre-in-charge.
- 8. Students who are found to have committed any act of indiscipline are liable for any one or more of the following punishments:
