Specific diseases/ailments for treatment:

- Renal failure
- Cancer
- Heart ailments viz., Angioplasty, Bypass Surgery, Placing of stent / pacemaker in Heart including investigations, Cardiac pace maker, combo device, AICD, Rotoblator and Aortic stent graft, etc.
- · Liver ailments including Hepatitis C & D and liver Cirrhosis
- Knee Joint Replacement
- Transplantation (Kidney, Heart, Liver, Lungs)
- Prosthetic (Knee, joint, limb, etc)
- Knee joint and hip implantation.

Conditions:

- CIPET Centre should sign MoU/Agreement with the selected empanelled hospitals after completing the formalities as enunciated in our Circular No: CIPET/HO/PD-NP/Inpatient/MoU/2018, dated 12.09.2018
- The retired employees and their dependents shall avail treatment in CIPET approved CGHS empanelled hospitals only and their entitlement for Room (General ward / Semi private ward / Private ward) and other facilities will be regulated as per their last pay drawn.

- The hospital will provide medical facilities to the retired employees and their dependents on cashless basis based on ID card and raise bills to CIPET as per CGHS approved rates. No payment towards treatment will be borne by retired employees except extra facilities availed for food, room services, transport, telephone, etc., which are not covered under CGHS package.
- While providing cashless treatment (credit facility), it may be ensured that no interest is charged by the hospitals at the time of settling the claims.

The expenditure incurred for treatment of retired employees/dependents will be borne by the respective Centres where the employee got superannuated.

The post-settlement claims will be examined / regulated by a three-member committee at CIPET Head Office nominated by the Competent Authority. Hence, the bills with all supporting documents (including prescription, discharge summary, etc) will be submitted to CIPET Head Office within 10 days of settlement.

This shall come into force after signing of MoU / Agreement with the empanelled hospitals.

This is issued with the concurrence of the Competent Authority.
