## ENGAGEMNET OF LEGAL CONSULTANT (ON CONTRACT)

- 1) The application should be submitted only in the prescribed application form for advertised position for engagement on contract for limited or fixed period in CIPET, which can be downloaded from the website <u>www.cipet.gov.in</u>.
- 2) These positions are purely on contractual basis, renewable as per the applicable terms and conditions and based on performance/recommendations by the concerned reporting authority.
- 3) The outer cover should be super scribed with the name of the position applied for.
- 4) Incomplete/Unsigned applications and applications without required enclosures will summarily be rejected.
- 5) The Institute reserves the right to screen and call to participate in the selection process only such candidates who have been recommended by the Screening Committee. Mere fulfilling the eligibility conditions will not automatically entitle to a candidate to be called for participating in the selection process. Personal, academic, professional and all other details of candidates, basis for short listing, bench mark by the Screening Committee, all reports of the Selection Committee and each and every information in respect of the selection process shall be maintained in strict confidence and will not be revealed to anyone under whatsoever circumstances.
