**INSTRUCTION TO THE TENDERERS**

The Tender shall be submitted in accordance with the instructions and any tender is not comply with the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. The tender should be submitted in **sealed cover** super-scribed as "**SALE OF SCRAPS**".
2. In case Tender Document is downloaded from the web site, the cost of Tender Document i.e Rs. 590/- (Rupees Five Hundred and Ninety Only) including GST should be enclosed with the Tender by way of Demand Draft/Pay Order in favour of "**CIPET VTC Vijayawada**" payable at Vijayawada
3. The Tender shall be submitted along with the Earnest Money Deposit (EMD) declaration document as specified as Annexure - V
4. The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of Tenderer on all the pages.
5. The offer price shall be quoted for the scrap per kg basis "**AS IS WHERE IS BASIS**" plus GST Extra
6. The Tenderers are free to inspect the Scrap at the above address of CIPET-CSTS, Vijayawada on any working day from w.e.f. 01.02.2022 to 21.02.2022 in the presence of CIPET Officials.
7. The tender shall be awarded based on the highest offer received for individual item/stock. In other words, the successful bidder would be decided for each item based on the highest offer received for particular item. Accordingly the delivery of each item would be issued separately to selected bidder for that particular item. Up on award of the contract, the particular highest bidder shall deposit an amount equivalent to the 5% of the actual value of the scrap item as a Performance Guarantee which shall be returned to the party without any interest up on successful completion of the lifting of the items or within 60 days whichever is earlier.

**8. Procedure for disposal of Scrap:**

- a) The successful Tenderer shall deposit the total lump sum amount in Rupees for individual category of scrap as detailed under by way of Demand Draft/Pay Order in favor of "**CIPET VTC Vijayawada**" payable at Vijayawada towards the cost of Scrap (approx) within three working days from the date of awarding the order.

The details of lump sum amount to be paid for individual category of scrap shall be calculated as per the formula as under:

- b) It may be noted that the quantity as mentioned in above against individual category of scrap shall be considered as approximate quantity but the actual payment would be calculated on the basis of actual quantity of scrap to be lifted. In case the actual quantity is less than the quantity mentioned above Column 2, the balance amount will be returned.
- c) The truck/tempo for Scrap lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap to truck/ tempo at their own cost and CIPET-CSTS, Vijayawada will not pay any charges for the same.
- d) Prior to the loading of scrap on the Truck/Tempo, the empty Truck/Tempo shall be taken to the Weighing Bridge for weighing in presence of official from CIPET-CSTS Vijayawada.
- e) The loaded truck would again be sent to the weighing scale for weighing, and the weight of material would be calculated for payment of quantity of scrap based on the quoted price. The Weighing Bridge will be decided at random by CIPET official and the weighing bridge charges (if any) shall be borne by the H1 bidder.

CIPET-CSTS shall hand over the scrap to successful tenderers on the place where it is actually lying presently in the Campus.
3. The successful Tenderer shall bear the cost of weighing the empty & loaded Truck/Tempo.
4. CIPET officials shall accompany the Truck/Tempo arranged by the successful tenderer for weighing. The weighing bridge selected by CIPET officials for weighing the empty/loaded truck/tempo shall be binding on the Tenderer. The empty Truck/Tempo shall be directly brought to the CIPET after weighing.
5. Rate quoted will be valid up to 06 months from the date of awarding the order. The rate contract can be extended for another 6 months on mutual agreement and the terms & condition shall remain same.
