Salient information about the Tender:

- 1. The sealed Tender should be of two parts viz. Technical Bid & Commercial Bid. Part 1 Technical Bid along with EMD DD & Tender form DD shall be put in one cover and shall be super scribed as Technical Bid for Hiring of Goods & Private Vehicle at CIPET:CSTS, Madurai. Part 2 Financial Bid shall be put in another cover and super scribed as Financial Bid for Hiring of Goods & Private Vehicle at CIPET:CSTS, Madurai. Both the Technical bid and Financial bid covers shall be put in one separate cover and super scribed as Tender for Hiring of Goods & Private Vehicle at CIPET:CSTS, Madurai.
- 2. Technical Bid submitted without the EMD & Tender form fees shall not be accepted
- 3. Interested and eligible bidders may collect the tender documents from CIPET:CSTS,Madurai, Thiruvathavoor. By paying tender form fees of Rs.1,180/- which is non refundable.
- 4. Tender cost of Rs.1,180/- including GST (Non-refundable) and EMD will be accepted in the form of Demand Draft drawn on any Indian Nationalized Bank in favour of CIPET-CSTS payable at Madurai and shall be submitted at CIPET:CSTS Madurai as specified on or before 17.08.2021 upto 11:30 AM.
- 5. Tenderer which qualifies the technical bid will only be considered for opening of Financial Bid, rest of the financial bid will be rejected. CIPET: CSTS, Madurai reserves the right to reject any or all the tenders received without assigning any reason(s)

thereof.

Eligible Criteria for Bidders:-

- Vehicle must possess valid Pollution Certificate.
- Vehicle must possess valid Registration Certificate.
- Vehicle must possess valid Insurance.
- > Self declaration of no pending litigation (Annexure I)
- > The Bidders must have office in Madurai with proper evidence for faster & better serviceability.
- The firm should have GST registration.
- Experience of providing vehicle to government departments/PSU/ Universities would be desirable. (Annexure II) Copies of similar purchase order of last 3 financial years (2018-19, 2019-20 & 2020-21) to be uploaded as proof.
- Annual Turnover: 2 Lakhs during the last financial Year.
- Vehicle should not be more than 05 (Five) year old.
- Mini Van shall have minimum capacity 1.5 ton to 2.0 ton to carry finished product and raw material
- Mini Truck shall have minimum capacity 5.0 ton to 6.0 ton to carry finished product and raw material
- Car will be engaged on regular basis and minivan /mini truck will be engaged as per demand.
- Vehicle must be registered as Taxi with yellow plate.

TERMS & CONDITIONS:

- 1. The cost of the tender document fee of Rs. 1180/- (Rupees One Thousand One Hundred and Eighty only) and EMD Rs. 10,000/- (Rupees Ten Thousand) is to be paid by Demand Draft drawn on any Indian Nationalized Bank in favour of CIPET-CSTS payable at Madurai and shall be submitted at CIPET:CSTS Madurai.
- 2. The contract would be valid for a period of one year from the date of contract and can be extended for further Two years, on the basis of requirement, performance and at the sole discretion of CIPET: CSTS, Madurai.
- 3. The vehicle provided must be registered in Madurai and properly insured.
- 4. The Driver must have valid driving licenses and properly dressed up during the duty hours.
- 5. The Agencies will be solely responsible for any misconduct of the drivers.
- 6. No advance payment would be made. During the period of contract, the rates will not be revised.
- 7. TDS will be deducted at source from bill as per the Income Tax Act.
- 8. CIPET: CSTS, Madurai reserves the right to terminate the contract with 30 days notice without assigning any reason thereof.
- 9. In case of any Loss, damage or accident, total responsibility lies with agency/firm. The driver will be fully responsible in case of unauthorized / illegal materials are found in the vehicle during the use of the officials of the CIPET: CSTS, Madurai.
- 10. Parking & toll taxes will be reimbursable on actual.
- 11. Vehicle model hired on monthly basis should not be earlier than one (05) Year Old.
- 12. Payment shall be made preferably within 15 days following submission of original invoices in duplicate by the Service Provider.
- 13. The vehicle(s) should be in good condition and should be provided on time. Replacement of vehicle shall be done immediately in case of repair, maintenance or any other condition with equally good condition vehicle. The service provider shall be responsible for appropriate insurance coverage.

In this regard, the service provider shall maintain comprehensive general liability insurance, including contractual liability coverage adequate to cover the indemnity of obligation against all damage to any property arising out of, or in connection with, the services which result from the fault of the service provider, or its staff/driver. The service provider shall provide CIPET: CSTS, Madurai with certification thereof upon request.

- 14. The service provider/contractor should have enough resources to repair their vehicles in minimum possible time. When required, they should be in a position to substitute/replace or arrange extra vehicle at very short notice.
- 15. The service provider/agency shall not provide any person as driver who has not completed 18 years of age. The agency shall comply with all statutory provisions as laid down under various Labour Laws like Minimum wages, Contract Labour Act etc. In case of violation of any such statutory provisions, the agency will be solely responsible.
- 16. The firms whose tender for monthly hiring are accepted shall make Security Deposit of Rs. 50,000 (Rupees Fifty thousand only) within 07 days from the issue of offer of work order. It should be paid through online (i.e. NEFT/RTGS/Bank Guarantee) in our "CIPET:CSTS, Madurai, A/c No 166302000001419" Indian Overseas Bank, IFSC code: IOBA0001005 and offline (i.e. Demand Draft drawn on any Indian Nationalized Bank in favour of CIPET-CSTS payable at Madurai and shall be submitted at CIPET:CSTS Madurai) .The contract shall be signed only after furnishing of performance security. In case of breach of contract by the contractor, the performance security shall be forfeited by CIPET: CSTS, Madurai and the firm/agency shall be blacklisted in addition to the termination of the contract.
- 17. All the vehicles provided to CIPET: CSTS, Madurai should be in good road worthy condition and having valid documents / licenses from department and Insurance policy of the Driver & Vehicles with Pollution Certificate. The Tenderer shall be responsible for total maintenance of the vehicles provided by him.
- 18. The Tenderer shall provide vehicles as per requirement of CIPET: CSTS, Madurai and as and when required even at a short notice
- 19. GST TDS will be deducted at source from bill as per the Goods & Service Tax Act.
- 20. Bidders are requested to visit the CIPET website on a regular basis for necessary corrigendum / modification of the tender. No separate communication, paper advertisement shall be done in this regard.

21. <u>Bidder register under Micro & Small enterprise (MSEs) will be considered only for relaxation of EMD not for Tender fees</u>

- 22. A Hatchback / Electric hatchback is a passenger car in a two-box configuration with separate compartment for engine, passenger, and cargo like Swift, Hyundai i10, Hyundai i20, TATA Tiago etc.
- 23. Service provider shall ensure that assigned vehicle and driver report as per schedule provided by user department / buyer/ individual user. In an event of delay arrival beyond 30 minutes, user shall have right to hire other taxi services (which may or may not be similar hired vehicle category). The fare shall be debited to the service provider.

ADDITIONAL TERMS AND CONDITION FOR MONTHLY HIRED VEHICLE:

- 1. In addition to terms and conditions mentioned above, the following additional terms and conditions shall be applicable on vehicles taken on monthly hire:-
- 2. The bio data of driver should be submitted before award of the contract.
- 3. The driver shall be in proper. Behavior of the driver should be extremely courteous and refined. He should be well aware of and should meticulously follow traffic rules. He should not be in habit of rash and fast driving and should have proper vision. He should have absolutely clean background and police record. A self-declaration certificate shall be furnished by the selected vendor/agency.

- 4. Driver shall be provided with mobile phone for smooth communication.
- 5. The duty timing of the monthly hired driver would be normally from 8 am to 8 pm but could be longer as per requirement and need. Accordingly the driver needs to be paid/compensated for overtime and other allowances by the agency.
- 6. One day compulsory rest in a week shall be given to the driver. On the day of rest, alternate driver shall be provided by the agency/service provider as per the need of CIPET: CSTS, Madurai.
- 7. The agency will have to provide the replacement of driver in case of any eventuality. CIPET: CSTS, Madurai has the right to ask the agency for removal of any Driver who is not found competent or disciplined.
- 8. Once assigned, the vehicle will not be changed/ replaced without prior permission of CIPET: CSTS, Madurai.
- 9. There will be separate log book for monthly vehicle maintained by the driver/agency. All entries in the log book will be verified/ countersigned by the concerned officers.
- 10. The service provider/firm shall submit attested copies of owner book, insurance papers and other papers of the vehicle and attested copies of driver license.
- 11. Vehicle must be stationed at CIPET: CSTS, Madurai.
- 12. In addition to monthly vehicle the agency must be capable of providing casual vehicle on Need basis as per the list provided in the commercial bid for casual vehicle.
- 13. The successful bidders will enter into contract with CIPET: CSTS, Madurai as per above terms and conditions within a week of finalization of the bidding process. Failure on the part of the bidder to do so may result in cancellation of its candidature.
