

• CIPET: CSTS -Korba invites Expression of Interest for Empanelment of Uniform, T-Shirts, Shoes and Bags Suppliers for the Supply of above items as per the requirement of the institute time to time basis per year at CIPET: CSTS -Korba.

For Long Term Course (LTC) Students:

- Boys Student (1 Set) 250 Sets (approx.) per year.
 2 Shirts, 2 Trousers and 1 Apron, 1 Safety Shoes
- Girls Students (1 Set) 150 Sets (approx.) per year.
 2 Kurti, 2 Salwar & Chunni and 1 Apron, 1 Safety Shoes

For Short Term Course (STC) Students:

- Boys Student (1 Set) 250 Sets (approx.) per year.

General Instructions and Terms & Conditions

- **1.** Any EOI received after the scheduled time or incomplete in any manner will not be accepted.
- **2.** The bidder is advised to examine the present CIPET: CSTS -Korba's uniform/ Safety Shoes/T-Shirt/College Bags sample at the institute premises before submission of the bid.
- **3.** The bidder will be responsible for any defect in cloth, stitching, quality of material etc. The bidder has to replace the defective material without any cost and within a period of 07 days.
- **4.** The bidder (supplier/manufacturer) is expected to examine all instructions, terms & conditions, specifications in the EOI form. Failure to furnish information required in every respect will be the Bidders risk and may result in rejection of the bid.
- **5.** At any time prior to the submission of the bids, the Purchaser may, for any reason, whether at their own initiate or in response to the clarification requested by the prospective Bidder, may modify the Bidding Documents by amendments. The amendment will be notified in writing or by telephone to all prospective Bidders who have received the EOI documents.
- **6.** The bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to Contract.
- **7.** The bidder will be required to submit the EOI in two bid system in two separate envelopes as mentioned below:
 - Envelope No. I super-scribed as "Technical Bid" should contain an introductory letter of contractor along with copies of documents as evidence for the past experience. The supplier/manufacturer has to fill up Annexure "A" with his signature along with all supporting documents.
 - **Envelope No. II** super/scribed as EOI for **"Financial Bid"** and should contain the EOI form duly signed on each page by contractor/authorized signatory along with the price bid. The supplier/manufacturer has to fill up **Annexure "B"**.

Both Envelope I & II should be placed in a large envelope which should be superscribed as **"EMPANELMENT OF SUPPLIERS/FIRMS FOR SUPPLY OF STITCHED UNIFORM, T-SHIRTS, SAFETY SHOES AND BAGS**" and addressed to **Director & Head, CIPET: CSTS- Korba, Education Hub, Syahimudi, Post Gopalpur via Jamnipali, Block Katghora, Korba (C.G.) -495450.**

- **8.** If the envelope is not sealed and marked, the Purchaser will assume no responsibility for the bid's misplacement or premature opening.
- **9.** Bids must be received by the Purchaser at the address specified under commercial bid not later than 5.00 PM on 17/08/2022.
- **10.** The Purchaser may, at its discretion, extend this deadline for the submission of bids by amending the Bidding Documents, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
- **11.** (i) The large envelope (containing separate envelope I Technical Bid) will

be opened first in the Presence of the bidders on 19/08/2022 at 11.00 AM.

- (ii) Those bidders who have not enclosed Technical Bid documents & not submitted it, in such cases their Envelope II which contains the financial bid will not be considered.
- (iii) The bidders will be pre-qualified in the technical bid, which fulfils the following criteria:
 - Valid GSTIN No.
 - Valid PAN No.
 - Valid Bank Account No. With IFSC Code
- (iv) The contract will be awarded to the L1 bidders in the financial bid.
- (v) One or more bidders may be awarded as L1 party for different items.
- (vi) If the price quoted by two or more suppliers/ manufacturer is same then the bid will be finalized on the basis of past experience of the Bidders. However, the decision of Centre Head will be final & binding on all the bidders.
- **12.** Looking to the urgency of work, the order may be given to any of the bidders who are ready to supply the items on L1price.
- **13.** CIPET reserves the right to reject any or all EOI in full or part thereof without assigning any reason.
- **14.** The Director & Head, CIPET:CSTS Korba is the final authority and his decision will be final and binding on the supplier for any disputes.
- **15.** All legal disputes will have the jurisdiction of Korba only.
- **16.** The Tailoring firm/Supplier/firm/ Dealer/ Manufacturer will be responsible to supply uniforms and safety shoes as per specification and Size provided by CIPET.
- **17.** The Tailoring firm/ Supplier firm/ Dealer/ Manufacturer will be responsible to supply uniforms and safety shoes within the specified time i.e., 30 Days from the contract award, otherwise a penalty equivalent to the 05% of the work order value may be charged.
- **18.** Duration of the contract will be initially valid for 01 year from the date of contract award, it may be extended on the satisfactory performance of the party on yearly basis for next 2 years.
- **19.** No bidder shall contact the purchaser on any matter relating to its bids, from the time of bid opening to the time the contract is awarded.
- **20.** The CIPET reserves the right to make changes in the specifications/pattern of the uniform, t-shirts, safely shoes& bags before or during the period of the award of contract or change the pattern/design of logo with embroidery in place of detachable logos on the uniform of the students or any other changes required in maintaining the similarity in the uniforms. No extra charges will be made on such changes.
