Delivery at designated site is at the expense of the bidder and the exact address of Premises/location for Supply & Installation of Hydrostatic Pressure Tester for Pipes will be mentioned in the Purchase Order / Work Order. CIPET will not be liable for any additional expenses incurred in this regard.
4. Bidder shall submit documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre – qualification criteria.

In case of non-receipt of supply & installation of equipment in all aspect as per the requirement within 60 days from the date of issue of the Purchase Order / Work Order CIPET has right to charge Liquidated Damages @ 0.50% per week subject to maximum of 10% of the total Purchase Order / Work Order value.
