ELIGIBLITY & QUALIFICATION CRITERIA FOR TECHNICL BID

Technical bid should include photocopies of the following documents, duly self-attested, failing which their bids shall be summarily/out rightly rejected and will not be considered any further:

- (a) Registered Office or one of the Branch Office of the Company/ Firm/ Agency should be located from Valsad or nearby area.
- (b) The bidder should possess valid **GST Registration.** Self-attested copy of the same must be submitted with the technical bid duly bearing seal of bidding firm/agency.
- (c) The Company/Firm/Agency should submit the technical Bid in prescribed Performa as mentioned under **Documents to be submitted in separate envelope written with "Technical Bid"** with self-attested copies of documents indicated in compliance with the above requirements should be kept with the Technical Bids envelope.
- (d) The Bidder, who have executed project for supply, Shifting and installation / commissioning of same or similar Category Products in Ministries/Departments/ Organizations of the Government of India/State Government, PSUs, Nationalized Banks, Private Firm etc. shall given first preference.

- 6. Bids once submitted shall not be allowed to be withdrawn.
- 7. The bidders may inspect the machinery/equipment on predetermined dates specified in the EoI satisfy themselves about the items they are bidding for.
- 8. It will be the sole responsibility of the successful bidder to ensure the safety of the machineries/ equipments/structure and other materials to save them from damage etc. at the time of removing, lifting, carting, etc. Repairs/damage if any during the process of dismantling would be borne by the successful bidder.
- 9. Payment will be made within 30 working days after completion of work and receipt of satisfactory report from the concern engineers/officer of this Institute i.e. CIPET: CSTS, Valsad.
- 10. CIPET: CSTS, Valsad reserves the right to accept or reject any/all bids without assigning any reason whatsoever.
- 11. General Conditions of Contract (GCC) shall form part of this EoI Document (attached separately) and sign all the paper of the EoI documents.
- 12. Machineries / equipments supplied under the Contract shall be fully insured against any loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified. The insurance of all the machinery of CIPET: CSTS, Valsad which is to be shifted to other location i.e. Block No.: B-364 & D368. At & P.O.: Khund, Tal. Chikhli, Dist. Navsari is done by CIPET: CSTS, Valsad
- 13. With a view to ensure that claims on insurance companies, if any, are lodged in time, the bidders shall be responsible for follow up with their principals for ascertaining the dispatch details and informing the same to the Purchaser and he shall also liaise with the Purchaser to ascertain the arrival of the consignment after clearance so that immediately thereafter in his presence the consignment could be opened and the insurance claim be lodged, if required, without any loss of time. Any delay on the part of the bidder would be viewed seriously and he shall be directly responsible for any loss sustained by the purchaser on the event of the delay. He shall be responsible for all damages and accidents caused due to negligence on his part. No hindrance shall be caused to traffic during the execution of work.

- b) The contractor shall be responsible for ail injury to persons, animals or things, and for all damage, whether such injury or damage arises from carelessness or accident in any way connected therewith. This clause shall be he'd to include interlay any damage due to causes as aforesaid to work, building (whether immediately adjacent or otherwise) and to roads, streets, foot paths, bridges or ways as well as all damage caused to the buildings and works forming the subject of this contract by inclemency of weather. The contractor indemnifies the Employer and holds him harmless in respect of ail expenses arising from such injury or damages as aforesaid and also in respect of any award of compensation or damage consequent upon such claim including legal costs.
- c) The contractor shall reinstate all damage of every sort mentioned in this clause, so as to deliver the whole of the contracted works complete and perfect in every respect and so as to make good and otherwise satisfy all claims for damage as aforesaid to the property of third parties.
- d) The contractor also indemnifies the Employer against all claim which may be made upon the Employer for acts during the currency of this contract by any employee or representative of an employee of the contractor or any sub-contractors, employed by him, for any injury to or loss of life, of such employees, or for compensation payable under any law for the time being in force to any workmen or to the representative of arty deceased or incapacitated workmen.
- e) The contractor also indemnifies the Employer against all claims which may be made upon the Employer for acts during the currency of this contract by the Central/State Government or local Municipal authorities for the non Compliance of any laws, regulations, rules pertaining to wages act, safety act in force and any amendments thereof in respect of all labour and apprentices directly or indirectly employed in the work Under this contract.
- f) The Employer shall be at liberty and is hereby empowered to deduct the amount of any damages, compensation cost, charges and/or expenses arising or accruing from or in respect of any such claim and / or damages as aforesaid from any sum or sums due or to become due to the contractor or security deposit.
- g) The contractor shall indemnify the Employer against any action, claim or proceedings relating to infringement or use of any patent or design or any alleged patent or design rights and shall pay any royalties which may be payable in respect of any article or part thereof included in the contract. In the event of any claims made under or action brought against the Employer in respect of any such matters as aforesaid the contractor shall be immediately notified thereof and the contractor shall be at liberty, at his own expense, to settle any dispute or to conduct any litigation that may arise there from.
