- Delivery at designated site is at the expense of the bidder and the exact address of Premises/location for Supply & Installation of Hydrostatic Pressure Tester for Pipes will be mentioned in the Purchase Order / Work Order. CIPET will not be liable for any additional expenses incurred in this regard.
- 4. Bidder shall submit documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre qualification criteria.
- 5. Offer should be in two parts Viz., "TECHNICAL BID" and "FINANCIAL BID" and all bids must be submitted through the online portalwww.tenderwizard.com/CIPET.
- 6. Any Tender received after the last date for submission of E-Tenders prescribed in the tender, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.

- 8. The Qty of Raw material to be supplied is 30 Tons and the delivery Schedule of material should be as per Purchase Order

In case of non-receipt of supply & installation of equipment in all aspect as per the requirement within60 days from the date of issue of the Purchase Order / Work Order CIPET has right to charge Liquidated Damages @ 0.50% per week subject to maximum of 10% of the total Purchase Order / Work Order value.
