2. The bidder is advised to examine the present CIPET :CSTS Aurangabad uniform at institute premises before submission of the online bid.
3. The bidder will be responsible for any defect in cloth, stitching, quality of material etc. The bidder has to replace the defected material without any cost and within period of 7 days.
4. The bidder has to submit the authorized Dealer/Distributor/Agent/Reseller/ certificate of the brand.
5. The label indicating the size of Shirt & Trouser shall be clearly indicated on the packaging.
6. Any Tender received by the CIPET: CSTS Aurangabad after the deadline will be rejected.
7. The bids shall remain valid for period of 90 days from the date of tender.
8. CIPET: CSTS Aurangabad reserves the right to award either or both the works to single or different parties.
9. The delivery period for Supply of stitched uniform for Shirts / T shirts with CIPET Logo & Trousers is 20 days.
10. The Purchase Order/Work Order shall be awarded to the lowest bidder in each of the above category.
11. In case of work not completed satisfactory or in case of delay, CIPET: CSTS Aurangabad reserves the right to forfeit the EMD and impose penalty as decided by CIPET: CSTS Aurangabad. The decision of CIPET :CSTS Aurangabad shall be final in all matters and binding on the bidder.
12. TDS (Tax Deducted at Source) and any other applicable tax shall be deducted as per prevailing rules and regulations of the Government, if applicable.
13. Financial Bid should be submitted in the prescribed format as given in the tender document.
