1. **Each page of the tender document is required to be signed by the tenderer.**
2. The tenderer is free to inspect the scrap and its present condition before submission of their offer. The scrap now available for sale can be inspected on specified dates and timings as indicated in the EOI Notice with prior permission from the officer in charge.
3. In case of taking weight of the items at the time of delivery, the weight will be ascertained in the Weigh Bridge to be arranged by the bidder before a committee. The successful bidder shall remit the cost of the Scrap and applicable taxes as prescribed in the Sale Order before taking delivery of the items from CIPET CSTS Aurangabad
4. Sale will be based on actual quantity available. No claim for variation in quantities will be entertained. Any clarification required may be obtained before submission of the tender.
5. Tenderer shall ensure that CIPET CSTS Aurangabad properties are not damaged during the course of removal of the scrap and if any damage or loss is caused, the same shall be made good by the tenderer.
6. All statutory payments, like minimum wages prescribed, compensation in case of accident or loss, etc. to the workers employed by the tenderer for the removal of the items shall be borne by the tenderer. Safety Rules applicable to Contractor's Workmen should be strictly followed while working in CIPET CSTS Aurangabad premises for the collection/loading/unloading of the scrap
7. The tenderer will not be permitted to sort out the materials. However if any of the item which CIPET CSTS Aurangabad feels to be useful in future for their use will be withdrawn from the sale lot.
8. The EMD of unsuccessful tenderers shall be returned within one month from the date of award of work order. The Earnest Money Deposit shall be adjusted against billing price of the scrap at the end.
9. The successful bidder should have to **deposit 100% payment** along with applicable taxes through online before lifting the material and tenderer should lift the material within 10 days from date of release of order, otherwise the EMD will be forfeited.
10. All the material has to be lifted in the presence and as per instructions of the authorized person/Committee of the Institute. The security person on duty at the gate of Institute will have absolute signed to check/inspection. Hence, the Director & Head CIPET: CSTS, Aurangabad final decision in all cases of any disputes.
11. The items may be splitted between the tenderers based on the highest rates offered by the tenderers. **The purchaser has to arrange their own labour and transport of lifting the material and also pay the cost of weighting the scrap material at Dharam kata.**
12. The tender shall be accepted on the basis of highest offered rates by the tenderers for each item. In case equal rates are received for an item, the items will be offered first to the tenderes who has offered highest rate in other items. If there is no tenderer who has offered highest in other items, the material will be splitted between the bidders equally.
13. The material so identified for lifting will be lifted and transported out of the campus during the working hours only.
14. The offer rates of the party/parties shall be valid up to 3 month for work order.
15. The scrap shall be weighted in the presence of CIPET: CSTS, Aurangabad representative.
16. If there is any loss to the property of CIPET: CSTS, Aurangabad while lifting the scrap, the purchaser has to compensate this loss.
17. **The GST and TCS as applicable will be charged extra at the prevailing rate.**
18. CIPET: CSTS, Aurangabad reserve the right and cancel any or all items without assigning any reasons and the decision of management shall be final and binding in all cases.
19. All legal matter will be under Aurangabad Judiciary only.
