**INTRODUCTION, BACKGROUND & OVERVIEW**

Central Institute of Plastics Engineering & Technology (CIPET) is a premier national institution under the Ministry of Chemicals & Fertilizers, Govt. of India fully devoted to Skill Development, Technology Support Services, Academic and Research (STAR). CIPET operates from various locations spread across the country catering the needs of Polymer and allied industries.
2. The institute is looking for contractors for Tree cutting works. The Institute is planning to construct a Tool Room Shed & Hostel for students. CIPET:IPT, Kochi wants to clear the space for construction.
3. The objective of this document is to empanelment of contractors with CIPET for providing the Tree Cutting works.
4. The bidder is to be submitted in two parts comprising Part –I Technical Bid & Part –II Price Bid. The Part-I (Technical Bid) should contain the EMD of Rs. 25,000/- (Rupees Twenty Five Thousand Only). The Part –II (Price Bid) should contain only the price offered as per attached Financial Format. Both the parts should be properly marked and enclosed in separate TECHNICAL BID and PRICE BID should again be sealed in a third bigger envelope **superscribing the EOI No. and “ EXPRESSION OF INTEREST (EOI) FOR TREE CUTTING WORKS**. ### **Terms and conditions:**

1. The bidder shall mention the quoting value in the Annexure – 2 in the prescribed column. Bidder shall submit the Annexure – 1 & 2 in sealed covers which shall be opened in the presence of all the bidders with due intimation of the date of opening.
2. The person who desires to participate in the EOI shall have to deposit earnest money of Rs.25,000/- in the form of Demand Draft (D.D) in favour of the CIPET: INSTITUTE OF PLASTICS TECHNOLOGY (CIPET:IPT, KOCHI), payable at Ernakulam. And without EMD tender will be disqualified.
3. The intending tenderers are advised to inspect personally, the area in the CIPET: IPT Kochi Campus, from which the wood/Tree is proposed to be harvested, to know the quality of material, location and terrain, for which they intend to submit tenders and satisfy themselves.
4. The prospective bidders who wish to participate in the bidding process must submit the documents mentioned in Annexure -I on or before 21.09.2020 by 05:00 PM. In case of any of the mandatory document mentioned in Annexure - I is not found in the sealed bid application, the bidder will be disqualified from the bidding process.
5. After completion of bidding process 50% of the highest bid amount will be deposited within 48 hrs by the highest bidder and the balance amount shall be deposited on approval of the highest bid by the competent authority within the specified time as would be communicated to you. In case the bid money is not deposited within the stipulated time period, the earnest money and the entire bid amount deposited shall be forfeited and the contractor shall be liable to be blacklisted from the list of contractors.
6. The EMD will be refundable to the contractor after completion of the contract without causing any damages to the Government property. The successful bidder shall be responsible for any damage caused to the Government property viz building, electrical wires, cables, telephone cables and etc and other standing trees which are not included in the Tender. The pits will be filled to level the ground to its original conditions.
7. The successful bidder will have to cut the trees according to the instruction given by the nominated authority from this office. No cutting/removal will be allowed before Sunrise and Sunset as well as on Sunday/Public Holidays. The contractor shall make his own arrangement for stay of laborers if needed. They shall not be allowed to stay inside the premises after sunset. The trees shall be cut and removed with their roots. All rubbish shall be cleared off and thrown out into a scheduled area as per the government instruction at your end and on his failure the Centre shall get remove such rubbish at the risk and cost of the buyer.
8. The full amount of the bid plus applicable taxes/surcharges will also be recovered from the successful bidder.
9. Any person/bidder/contractor found indulging in unfair means adversely affecting the bidding process, will be liable to legal and punitive action. Such persons/bidders/contractors will also be liable to be debarred from the further tender proceedings besides being blacklisted for future tender. The decision of Principal Director & Head shall be final in this regard.

10. The trees will be cut/ removed by the highest bidder whose bid has accepted within a period of 20 days from the date of allotment of work order. The trees not removed within the aforesaid period shall be forfeited and the contractor shall have no claim over such confiscated trees.
11. The contract shall not be assigned or sublet without the prior consent in writing of the Principal Director & Head whose decision in this regard shall be final and binding
12. The contractor shall cut and remove only those trees tendered and in case of removal of any extra trees, the contractor shall be liable pay the damage both in terms of monetary and legality. The contractor can also be blacklisted from participating in any future tender. Also, the contract is liable to be cancelled in midway and security deposit shall be forfeited. The Competent authority reserves all rights to resale the balance No. of trees and the defaulting contractor will have no claim, whatsoever, on this account.
13. It is the responsibility of the contractor to get the essential clearances from the forest and the civil police authorities, as needed under the rules at his/her own cost for loading/transportation of the tendered wood/trees. And in any case this office shall not be responsible for the same and no claims/correspondence whatsoever will be entertained by this office.
14. All security measures/precautions required to be observed in the area will be followed by the contractor and the workers/men employed by him. Contractor shall indemnify against any loss/damage to the Govt. or his/her laborers.
15. This office will not be responsible for any Civil/Criminal/Legal dispute of the contractor arising after the cutting of the trees/during the transportation of the cut wood/timber. The contractor shall be bound to follow all the prevailing rules and regulations during the cutting/removal of trees and transportation of the wood.
16. In case of any dispute, that will be within the jurisdiction of Ernakulam district only.
17. The EMD of successful tenderer who fail to enter with agreement and deposit the security deposit as per terms of tenders will be forfeited.
18. It is the responsibility of the Bidders to download the Terms & conditions in the website and submits the same duly signed along with the Bid.
