- The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required for the Tender Documents or submission of a Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer's risk and may result in rejection of the Tender.
- 2. The purchaser shall not be liable for any expenses whatsoever incurred by the Tenderer in the preparation of the tender whether his tender is accepted or not even if the purchaser opts for complete withdrawal of invitation of Tender.
- 3. The Tenderer is advised in his own interest to examine the present CIPET uniform at institute premises before submission of the bid.
- 4. Measured by the Tailor / Contractor at CIPET Vijayawada Office premises as per the instructions provided by the CIPET.
- 5. Supplier shall be solely responsible for any defect in stitching, quality of material etc. which may result in poor quality.

- 6. The rate quoted by the L1 bidder shall be valid for a period of 01 year from the date of issue of Purchase order. However, if CIPET: CSTS, Vijayawada is willing to terminate the rate contract, can terminate the same with intimation to the L1 bidder without assigning any reasons immediately. If the L1 bidder wants to terminate the rate contract with in applicability period, the performance security of the L1 bidder shall be forfeited.
- 7. The Qty of uniforms to be supplied to the institute and the delivery Schedule of items should be as per the Purchase Order issued from this office from time-to-time.
- 8. Documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre qualification criteria.
- 9. Offer should be in two parts Viz., "TECHNICAL BID" and "FINANCIAL BID" and all bids must be submitted through the online portal www.tenderwizard.com/CIPET.
- 10. Any Tender received by the Purchaser after the deadline for submission of E-Tenders prescribed by the Purchaser, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.

- 14. The cost of tender document is Rs. 1,180/- (Non Refundable) and Tenderers are requested to submit the tender fees on or before 14.12.2022, 05:00 PM, by way of Online, failing which the tenders of that party will be rejected.
- 15. **EMD (Earnest Money Deposit) :** In compliance to the No. OM released by Procurement Policy Division, Department of Expenditure, Ministry of Finance, Government of India vide No.: F.9/4/2020-PPD, dated: 12.11.2020, the Earnest Money Deposit (EMD) to be submitted by the bidders shall be treated as "NIL"
