#### SCHEDULE OF REQUIREMENT

CIPET: IPT, AHMEDABAD invites sealed bids from the reputed and financially sound agencies / bidders for providing outsource manpower services to CIPET: IPT,AHMEDABAD in a two-bid system considering the following conditions:

- 1. CIPET: IPT,AHMEDABAD has initial requirement of manpower as detailed in "Section-C" (Technical & Non-Technical requirement of Manpower) of the tender document. The requirement of CIPET: IPT, AHMEDABAD is only indicative and may further increase or decrease during the period of contract subject to work load and exigency of assignments.
- 2. The remunerations indicated in "Section-C" is excluding statutory to be made such as ESI and EPF, etc. The contract will be initially for a period of one year and is likely to commence from the date of deployment of manpower after completing pre-deployment formalities listed in the tender document which may be extended for a further period of one year depending upon the requirement of manpower, administrative convenience of CIPET: IPT, AHMEDABAD and performance of the agency.

## A. LIABILITIES AND CONTROL, ETC. OF THE PERSONS DEPLOYED

1. The successful agency/ bidder shall ensure that the individual manpower deployed at CIPET: IPT, AHMEDABAD confirms to the technical specification of education and skill prescribed in "Section-C" of the tender document.

2. The successful agency/bidder shall furnish the list of persons to be deployed along with the following documents in respect of the individual manpower who will be deployed by them at CIPET: IPT, AHMEDABAD before the commencement of work:

a) Bio-data of each person along with self-attested copies of the certificates in respect of their educational / professional qualifications, etc.

b) Attested copy of matriculation certificate containing date of birth.

c) Certificate of verification of antecedents of person by local police authority.

d) Detailed proof of identity like driving license, bank account details, proof of residence and 2 Nos. recent passport size photographs of the personnel to be deployed by the agency in CIPET: IPT, AHMEDABAD.

3. The successful agency/bidder shall ensure that the personnel deployed are medically fit and also submit covid-19 vaccination certificate .

4. The successful agency/bidder shall be responsible for proper conduct of his/her/their personnel at CIPET: IPT, AHMEDABAD premises. In case of any damage/loss/theft etc., to the property of CIPET: IPT, AHMEDABAD which is caused by the personnel deployed by the agency, the agency will either be liable to make good the loss on the basis of the value of the property as determined by CIPET: IPT, AHMEDABAD or the same could be recovered from the performance guarantee, monthly payments due to the agency.



5. The personnel deputed to CIPET: IPT, AHMEDABAD by the successful agency/bidder should be polite, cordial, positive and efficient while handling the assigned work. In case, the person employed by the successful agency/ bidder commit any act of omission/commission that amounts to misconduct / indiscipline/ incompetence, the successful agency will liable to take disciplinary action against such persons, including their removal from the work, if required by CIPET: IPT, AHMEDABAD.

6. The personnel deputed to CIPET: IPT, AHMEDABAD shall not be changed by the agency under any circumstances unless there is a specific request from the institute.

7. It will be the responsibility of the successful agency/bidder to meet transportation, medical and other requirements in respect of the persons deployed at institute premises and CIPET: IPT, AHMEDABAD will have no liabilities in this regard.

8. For all intents and purposes, the successful agency/bidder shall be the 'employer' within the meaning of different labour legislations in respect of manpower so deployed at Institute. The persons deployed by the agency/bidder at institute shall not have claims of any employer and employee relationship against CIPET: IPT, AHMEDABAD.

9. The successful agency/bidder shall be solely responsible for the redressal of grievance/ resolution of dispute relating to persons deployed. The Institute shall in no way be responsible for settlement of such issues whatsoever.

10. The Institute shall not be responsible for any financial loss or any injury to any person deployed by service providing agency/bidder during the course of their performing the functions/duties or for payment towards any compensation. The agency should take appropriate policy for its coverage.

11. The persons deployed by the successful agency/bidder neither have rights to claim nor entitled to pay, perks and other facilities admissible to the regular employees of institute during the currency or after expiry of the contract.

12. In case of termination of the contract on its expiry or otherwise, the persons deployed by the successful agency/bidder shall not be entitled to and will have no claim for any absorption or engagement in any capacity in the CIPET: IPT, AHMEDABAD.

## B. LEGAL

1. The successful agency/bidder shall be responsible for compliance of all statutory provisions relating to minimum Wages, Provident Fund and Employees State Insurance, payment of Bonus, etc., in respect of the persons deployed by them at CIPET: IPT, AHMEDABAD.

2. CIPET: IPT, AHMEDABAD apart from the remuneration, will reimburse to the agency all statutory charges towards ESI, EPF as applicable to the institute under prevailing law from time to time.



3. The successful agency/bidder shall also be liable for depositing all taxes, levies, cess etc., on account of services rendered to CIPET IPT, AHMEDABAD to concerned tax, ESI, EPF authorities from time to time as per extant rules and regulations. In case, the successful agency/bidder fails to comply with the statutory/taxation obligation under appropriate law, and as a result thereof, CIPET: IPT, AHMEDABAD is put to any loss/obligation, monetary on otherwise, the CIPET: IPT, AHMEDABAD will deduct the same from the monthly bills and/or the performance security deposit of the agency/bidder, to the extent of the loss or obligation in monetary terms.

**4**. The successful agency/bidder shall maintain all statutory registers under the law. The agency shall produce the same, on demand to the concerned authority of the institute or any other authority under law.

5. The tax deduction at source (TDS) shall be made as per the provisions of Income Tax Act and a certificate to this effect shall be provided to the agency by the institute.

6. The remuneration of the deployed personnel must be credited to their bank account by the successful agency/bidder latest by 7th of every month.

7. The successful agency/bidder shall present the bills for reimbursement of the remuneration latest by 10<sup>th</sup> day every month so that the same can be processed at the earliest. However, the deadline of payment of the persons deployed by the agency shall not be altered by the agency even if payment is not received or delayed from CIPET: IPT, AHMEDABAD.

#### C. TECHNICAL & NON-TECHNICAL REQUIREMENT OF MANPOWER TO BE DEPLOYED

The eligibility criteria for personnel to be deployed by successful agency/bidder in CIPET: IPT, AHMEDABAD shall be as per details given in Part -B of Schedule -I appended to Guidelines for Engagement of Manpower in CIPET on Contract, 2021. The details of requirement of services to be procured through successful service providing Agency/bidder are indicated below. Being the initial requirement, the number may vary as per exigencies:-

#### Note:

- 1. The educational qualification can be relaxed with the approval of Principal Director and Head, CIPET: IPT, AHMEDABAD.
- 2. Statutory charges like EPF and ESIC, as applicable from employer side, are excluded in the present remuneration mentioned in prepare. The remuneration is for deployment from 09:00 a.m to 5:30 p.m., 06.00a.m to 02.00pm and 02.00pm to 10.00pm including lunch of 30 minutes (working 6 days in week). However; depending upon exigency and requirement of work, engaged personnel may be required to work in shift duties also.



#### INSTRUCTIONS TO BIDDERS AND GENERAL TERMS & CONDITIONS

#### I - GENERAL TERMS & CONDITIONS:

1. The tender should be submitted in Two-Bid system. "Technical Bid" & "Earnest Money" and "Financial Bid". Both the covers should be kept in one sealed envelope.

2. The completely filled bid documents, duly sealed should be addressed to Principal Director & Head, CIPET:IPT, AHMEDABAD, Plot No. 630, Phase-IV, G.I.D.C. Vatva, AHMEDABAD-382445 and should reach on or before 12:00 p.m. on 23.07.2021 (date by Registered Post, Speed post or by hand at the above mentioned address duly super-scribed on the top of the envelope as "Engagement of Manpower Agency for Hiring Contractual Manpower through Outsourcing" at CIPET: IPT, AHMEDABAD, Plot No. 630, Phase-IV, G.I.D.C. Vatva, AHMEDABAD-382445

3. The tender documents shall be treated as "confidential".

4. Bid shall be submitted with a forwarding letter head of the bidder/agency duly signed and stamped by authorized signatory on each page to ensure the compliance of scope, services and general terms and conditions of the tender under reference.

5. Technical Bid should be submitted by the bidder strictly as per Bidder eligibility criteria with documentary evidence prescribed.

6. No overwriting, corrections and striking in the financial bid format is permitted and it will reject automatically. All entries in the bid/tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached.

7. Each page of the tender document should be signed and stamped by authorized signatory.

8. CIPET: IPT, AHMEDABAD, Plot No. 630, Phase-IV, G.I.D.C. Vatwa, AHMEDABAD-382445, reserves the right to modify/relax any of the terms & conditions of the tender.

9. Pre-Bid inspection/Survey: The bidder may visit CIPET: IPT, AHMEDABAD to have an understanding of the requirements during working hours of CIPET: IPT, AHMEDABAD and institute also having right to inspect the agency at any point of tendering process.

10. The selected bidder shall undertake to abide by all rules, regulations and laws and shall agree to keep itself liable and responsible for any such violation directly before Principal Director and Head, CIPET: IPT, AHMEDABAD / Competent Authority.

11. CIPET: IPT, AHMEDABAD may renew the contract for a further period on the same terms and conditions depending upon the requirement of manpower, administrative convenience of CIPET: IPT, AHMEDABAD and performance of the agency.

12. CIPET:IPT, AHMEDABAD shall not be responsible for postal or any other delays. Bid received in an envelope that is damaged/torn or merely stapled will summarily be rejected.

13. Bids once submitted shall not be allowed to be withdrawn. Any default after acceptance of bid shall be deemed to be non-compliance of the terms of contract and would be liable to forfeiture of EMD deposit and cancellation of contract.



14. Bidders/ authorized representative duly authorized in writing on letter head are requested to be present at the time of opening of the bids. If the date of tender opening, by any chance happens to be a holiday, the tender will be opened on the next working day at the stipulated time.

15.CIPET: IPT, AHMEDABAD however, reserves the right to terminate/curtail/cancel the contract at any time after giving one week's notice to the Agency owing to deficiency of service, sub- standard quality of manpower deployed, breach of contract, etc. In such case, successful bidder will not be entitled to any kind of compensation.

16. Once the rates are finalized, no increase will be considered in the rates quoted by the agency in any case during the period of contract.

17. CIPET: IPT, AHMEDABAD reserves the right to reject any or all the tenders or accept them in part or to reject lowest tender.

18. DD in favour of "**CIPET AHMEDABAD**" shall be submitted for Tender EMD cost, failing which, the bid will be rejected.

19. The successful bidder may also opt for premature cancellation of the contract by giving one months' notice in writing. If contract is cancelled without any notice, CIPET:IPT, AHMEDABAD reserves the right to forfeit the EMD/PG of the successful bidder.

20. The successful agency/bidder shall not be allowed to transfer, assign, pledge or sub-contract its right and liabilities under the contract to any other agency.

21. The bidder will be bound by the details furnished by him to CIPET: IPT, AHMEDABAD while submitting the tender/bid or at subsequent stage. In case such documents furnished by the bidder or successful bidder are found to be false or incorrect at any stage, it would be deemed to be a breach of terms of contract making him liable for legal action besides termination of contract.

#### II- Eligibility of Bidders:

(1) The bidders should be a company, registered under Indian Companies Act, 1956/2013 or a partnership firm, registered under the Indian Partnership Act or a proprietary concern. [Self – attested documentary proof should be provided.

(2) The bidder should have at least Five years' experience of deployment of different categories of manpower in Ministry/Departments of Govt. of India/Central PSUs/ Nationalised Banks/State Govt. Departments/ Autonomous /Statutory Bodies/ Corporations/Private firms. A copy of the experience certificate or work order(s) issued by the respective office should be provided.

(3) The bidder/Firm should have at least **Ten crores** of Turnover in respective preceding financial year

(4) The bidder/ Firm should have a bank account in its name. [A self-attested bank account statement for the last three months should be provided].

(5) The bidder should have established office at AHMEDABAD, GANDHINAGAR region and registered with Municipal Corporation from last three years. [A self-attested documentary proof should be provided].

(6) The bidder should furnish signed declaration indicating that they have carefully read the terms and conditions of the tender and accepted all the provisions of the tender document.

(7) The bidder should furnish a signed declaration indicating that they have not been blacklisted/ debarred by the Ministry/Departments of Govt. of India/Central PSUs/ Nationalised Banks/State Govt. Departments/ Autonomous/Statutory Bodies/ Corporations/Private firms and there is no litigation with any Government Departments/ court of law is pending on account of similar services.

(8) The tenderer/bidders are required to enclose attested photocopies of the documents listed below in the Tender Document along with the "Technical Bid" failing which the bids shall summarily be rejected and will not be considered further.

#### **TECHNICAL EVALUATION CRITERIA**

The bidder must fulfil the following technical criteria/attach the following required certificates in order to be eligible for financial evaluation and compliance of bid described in the tender document.

1. A self-attested Registration Certificate under the Companies Act, 1956/2013 or a partnership firm registered under Indian Partnership Act of Proprietary Concern.

2. A self-attested Registration Certificate under Contact Labour (Regulation & Abolition) Act, 1970.

3. A self-attested copy of PAN card.

4. A self-attested copy of the latest IT Returns filed preceding two financial year with the Income Tax Department.

5. A self-attested copy of EPF Registration certificate.

6. A self-attested copy of ESI Registration certificate.

7. A self-attested copy of the GST Registration certificate.

8. A self-attested bank account statement for the last six months.

9. The bidder should have at least 3 years experience of deployment of different category of manpower in Ministry/Departments of Govt. of India/Central PSUs/Nationalized Banks/State Govt. Departments/Autonomous /Statutory Bodies/Corporations/Private firms. A copy of the experience certificate/work order issued by the respective offices should be provided. The single work order value is Rs. 1 Cr or 02 work order value 50 lakhs each or 25 lakhs and more - 04 Nos is must for evaluation purpose.

10. The average annual turnover of the company/firm/agency should not be less than rupees Ten crores during the last three financial years. Copies of self-attested audited profit & loss account /income & expenditure account and balance sheets for the past two financial years should be provided.



### III - Award of Bidders:

### Financial Evaluation Criteria

1. The financial bid of only those bidders/tenderers whose Technical Bids are found in order will be opened. The financial bid shall be opened at a later stage. The scheduled time and venue for opening the financial bids will be communicated to only those bidder/tenderers whose Technical bids are found in order.

2. The evaluation of technical bid will be done by considering the parameters listed in section "Technical Evaluation Criteria" and in Annexure-1 (Technical Bid Document).

3. After evaluation of technical bids, the financial bids of only technically qualified bidders will be opened.

4. The bidders score will be determined on the basis of lowest service/agency charges, excluding ESI, EPF as applicable (arrived on the basis of comparison of financial quote of all the bidders).

5. The bidders, who quote unrealistic rate of service charges i.e. 0% shall be debarred for further consideration. If the percentage with more than 2 decimal points, then upto two decimal points only be considered without rounding up.

6. In case two or more bidders offer same percentage of service charges, then the bidder having highest turnover will be considered as L1.

7. The rates in the financial bid should be strictly as per Annexure – II.

#### IV - ISSUE OF LETTER OF INTENT

1. The issue of letter of intent / work order shall constitute the intention of CIPET: IPT, AHMEDABAD to award the work as specified in the tender document with the successful agency / bidder.

2. The bidder shall within one week of issue of letter of intent / work order should give his acceptance along with security deposit/ performance guarantee (PG) as mentioned in bid document.

3. The bidder shall also have to sign an agreement on Rs.100 non judicial stamp paper in the prescribed format to safeguard the interest of CIPET: IPT, AHMEDABAD.



#### DOCUMENTS TO BE SUBMITTED BY THE SUCCESSFUL AGENCY/ BIDDER BEFORE DEPLOYMENT OF MANPOWER

1. List of manpower shortlisted by the agency for deployment containing full details i.e., name, father's name, mother's name, date of birth, residential and permanent address.

2. Bio-data of all persons along with the supporting documents in respect of age, qualification, professional qualification and experience etc.

3. Detailed proof of identity like driving license, bank account details, proof of residence and recent passport size photograph of the personnel proposed to be deployed in CIPET:IPT, AHMEDABAD by the agency.

4. The EMD will be converted as interest free Performance security deposit on award of work order to successful bidder.

## V - VALIDITY OF QUOTATION:

Bid validity should be 120 days from the specified date of closing.

#### VI - PAYMENT TERMS :

1. The successful bidder shall submit the monthly bills in triplicate enclosing the certificate as mentioned in succeeding Para for payment.

- a) Acknowledgement of receipt of wages by personnel deployed duly indicating the earnings, deductions towards PF, ESI, etc.
- b) Copies of deposit of PF, ESI,GST, Taxes as applicable from time to time. All the taxes will be paid respective authority separately for CIPET: IPT, AHMEDABAD and challan will be attached with monthly claim bills.
- c) Bank statement showing debits from awarding agency's bank account towards payment of wages to its personnel deployed at CIPET: IPT,AHMEDABAD.
- d) Agency/Bidder has to submit separate GST challan with every monthly bill.

2. The TDS shall be made as per the provisions of Income Tax Act, as amended from time to time, and a certificate to this effect shall be provided by CIPET: IPT, AHMEDABAD to the agency.

3. First payment shall be released after furnishing performance bank guarantee/ security deposit as per tender.

4. The successful bidder shall make regular and full payment of remuneration as due to its personnel under service contract with salary slips as per Annexure-III and furnish necessary proof whenever required. The payment of personnel by the agency should be made on or before 7th day of every month. The attendance should be verified with administration department every month time to time.



5. The successful bidder will ensure the remittance of remuneration to the personnel deployed at CIPET:IPT,AHMEDABAD by directly transferring into their respective bank accounts.

6. The proof of challan/receipt deposited with the PF Commissioner and ESI office for the payment made towards applicable PF, ESIC for the previous month shall be submitted while claiming the bill for the current month. In the absence of the proof, the bills will not be processed.

7. Proof of Taxes as applicable from time to time deposited with the concerned Government agencies shall be submitted with the bill. The said taxes will be paid to respective authority separately in the name of CIPET:IPT Ahmedabad and said challan will necessarily enclosed with monthly claim bills.

8. In case CIPET:IPT, AHMEDABAD receives any complaint(s) regarding nonpayment of salaries to the personnel deployed by them will be paid within three days otherwise it will be adjusted in monthly claim bill.

## VII - BID SECURITY (EMI)/SECURITY DEPOSIT/PERFORMANCE GUARANTEE:

EMD of Rs. 10,00,000/- (Rs. Ten Lakhs) in the form of Demand Draft in favour of "CIPET AHMEDABAD" from any nationalized commercial bank should be submitted along with "Technical Bid". Demand Draft should be drawn on/after the date of publication of the tender.

EMD of unsuccessful bidders will be refunded after finalization of bids. The EMD will be converted as interest free Performance Guarantee/ security deposit on award of work order to successful bidder.

Successful bidder has to submit Performance Guarantee / Security deposit equivalent to Rs. 10 lakh as annual contract value in the form of D.D of a nationalized bank in favour of CIPET:IPT, AHMEDABAD, which should be valid for a period of 60 days beyond the completion of the contractual obligations by the bidder. In case, the contract is further extended beyond the initial period, the performance security will have to be accordingly renewed by the agency. The same will be returned after the completion of contract without interest.

**VIII** -The successful bidder will be required to execute an agreement as per Appendix "B4" with CIPET:IPT, AHMEDABAD within the period specified in the Letter of Intent/ work order on Rs.100/- non-judicial stamp paper.



#### IX - Forfeiture of EMD/ Security Deposit/ Performance Guarantee:

(1) If the successful bidder/agency refuses/fails to accept Letter of Intent (LOI)/Work Order issued by CIPET:IPT, AHMEDABAD or the works assigned to the agency/bidder are not done as per the scope of work/schedule of requirement, EMD/Security Deposit will be forfeited and the bidder will not be entertained for any tenders that may be published in future by CIPET: IPT, AHMEDABAD and blacklisted as per GOI norms.

(2) If the bidder withdraws tender before/after finalization of the tender, EMD will be forfeited.

(3) If the contract is terminated by CIPET: IPT, AHMEDABAD due to poor performance/violation(s) of any of the clause(s) of the Agreement or for any bad acts considered prejudicial by CIPET: IPT, AHMEDABAD of the selected bidder, security deposit/PG will be forfeited.

#### XV - BLACKLISTING

Performance of the contract agreement shall, however be resumed as soon as practicable after such eventuality has come to an end.

The CIPET: IPT, AHMEDABAD and the CONTRACTOR are individually referred to as a "Party" and collectively referred to as "Parties".
WHEREAS the CONTRACTOR has agreed to deploy manpower at the aforesaid location under CIPET: IPT, AHMEDABAD in accordance with Tender No date at the rates quoted by the Contractor vide their financial bid; and

Terms and Conditions:
1. Date of commencement of the contract would be (Date)The Agreement will be valid for a period of one year. The rates quoted by the Agency shall be fixed for a period of one year and no request for any change / modification shall be entertained before the expiry of the agreement period.
2. The Service Providing Agency must ensure compliance of the provisions of Employees Provident Funds & Miscellaneous Provisions Act, 1952, Workmen Compensation Act, along with other labour laws as applicable time to time.
3. All services shall be performed by persons qualified and skilled as per the eligibility criteria indicated for each category to execute the job responsibilities of the category of manpower hired for such services in Schedule – I Part – II.

#### 36. CANCELLATION BY DEFAULT:
