SPECIAL TERMS AND CONDITIONS / INSTRUCTIONS TO BIDDER

- 1. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. - 3. Bidder shall submit documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre qualification criteria.
- 4. Offer should be in two parts Viz., "TECHNICAL BID" and "COMMERCIAL BID" and all bids must be submitted through the online portalwww.tenderwizard.com/CIPET.
- 5. Any Tender received after the last date for submission of E-Tenders prescribed in the tender, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
- 6. Tenders shall remain valid for 180 days after the date of E-Tender.
- 7. The Total Qty of Raw material approximately for RP-PP is 35Ton & RP-HDPE is 55 ton for the period of Six Months and the delivery Schedule of material should be as per Purchase Order issued from time to time
- 8. The rate contract is valid for a period of Six Months from date of issue of letter of intent
- 9. The cost of tender document is Rs. 1,180/- Incl. of GST (Non-Refundable) and Tenderers are requested to pay the tender fees only through NFET/RTGS to the bank account details mentioned in SI. No. 4 (b).of Salient information about the E-Tender.
