### Instructions and Conditions to Bidders / Tenderers:

- 1. Tender / Quotation without Tender fee (Rs. 500/-) in the form of demand draft shall be summarily rejected.
- 2. Tenders should be sealed and addressed to the Manager (Project) & Head, CIPET Guwahati, PO Changsari, Dist- Kamrup, Pin 781101 super scribing the envelope "Tender for sale of Scrap Materials" so as to reach this office not later than 26.07.2021 till 01:00 PM. The tenders will be opened on 27.07.2021 at 10:00 AM in the presence of the attending tenderers or their authorised representatives.
- **3.** Each page of the tender document is required to be signed with seal by the tenderer. The tender document must be filled in English only. If any of the required documents are missing or unsigned, the tender may be considered as invalid. Overwriting of figures is not permissible.
- 4. The tenderer(s) whose tenders have been accepted have to deposit a Security deposit of Rs. 20,000/- (Rs. Twenty Thousand only) in the form of cash / DD / Banker's Cheque, drawn in favour of CIPET Guwahati payable at Guwahati within 3 days after the acceptance of the tender. The Security Deposit shall be adjusted against billing price of the scrap at the end.
- **5.** The successful tenderer has to lift the material within 10 days after payment through DD / Banker's Cheque. In case they fail to lift the material within 10 days, failing which Security Deposit paid shall be forfeited and tender cancelled.
- 6. All the material has to be lifted in the presence and as per instructions of the authorised persons of the Institute and on the basis of Gate Pass. The Security persons on duty at the gate of Institute will have absolute authority to stop transporting of the material in case of any doubt on checking/inspection. The Centre Head, CIPET Guwahati will take final decision in all cases of disputes in this regard.
- 7. The purchaser has to arrange their own labour and transport for lifting of the material and has to inform CIPET management one working day prior to their intent for lifting the scrap. Scrap shall not be lifted on ANY HOLIDAY or SATURDAY or SUNDAY.

- 8. The acceptance of tender will be based on the highest rate quoted for each item. CIPET management shall have the right to cancel the tender in case proper rates are not received.
- 9. The Tender shall be accepted on the basis of highest offered rates by the tenderers for each item. In case equal rates are received for an item, the item will be offered first to the tenderers who has offered highest rate in other items. If no tenderer offers highest in other items, the material will be splitted between the bidders equally. However, a bidder may withdraw his case in favour of other bidder. Submission of security deposit as detailed in clause no. 4 shall be applicable for all bidders in such case. In this respect, the decision of CIPET Management will be final & binding on the tenderers.
- **10.** All the intending bidders may inspect the scrap put up for disposal during the working hours of the institute. In any case it will be presumed that they have inspected and verified themselves about the material before quoting the rates.
- 11. Quotations below MRP (Minimum Reserve Price) shall not be accepted.
- **12.** The bidder shall lift the material from the premises after payment of full amount within the prescribed time limit, failing which they will cease the right to lift the material and the payment deposited shall stand forfeited.
- **13.** The scrap shall be weighted at the expenses of the tenderer in the presence of CIPET representatives for the identified items only. The bidder has to settle all the payments before issuing of Gate Pass.
- **14.** If there is any loss to the property of CIPET while lifting the scrap, the bidder shall be solely responsible and has to compensate the loss.
- 15. All Applicable taxes (direct & indirect) shall be charge extra on the selling price.
- **16.** CIPET reserves the absolute right to reject / partly accept any or all items or cancel the entire Tender Process without assigning any reasons and the decision of management shall be final and binding in all cases.
- **17.** Bidders are requested to visit the CIPET website on a regular basis for necessary corrigendum / modification of the tender as no separate advertisement shall be issued in this regard.
