#### **TERMS & CONDITION: -**

- **1.** Bids will be accepted through GeM (Governmet e marketing) portal only. Bidders should be registered on the GeM portal to participate in the auction process.
- 2. The items offered for disposal is on "As is where is & what is basis" at in un packed condition. The list of the items to be disposed off has been uploaded separately under Annexure-C.
- 3. Participationandbiddinginthebid/tendershallbetreatedasconclusiveevid enceofthefactthatthebidderhasinspectedtheitemsanddocumentspertain ingto it and is satisfied in all respects regarding quantity, quality, and and another theitems.
- 4. The Bidders / Tenderers are required to upload their offer in two parts (Technical & Commercial Bid) separately. The first part shall consist of EMD of Rs. 10,000/- (Rupees Ten Thousand only) in the form of NEFT / Bank Transfer with filled in details as per annexure E. The Biders / tenderers should note that they are not required to disclose their quoted price in the first part. The second part shall consist of tender document issued to them and offer of rates in the appendix.
- 5. Each page of the tender document is required to be signed by the bidder/tenderer. The bidder / tender document must be filled in English and all the entries must be hand written in ink. If any of the documents are missing or unsigned, the tender may be considered as invalid. Overwriting of figures is not permissible.
- 6. The Bidders / Tenderer whose tenders have been selected have to deposit the Security deposit of 3% of the work order rate in the next working day after the acceptance of the bid/tender. Earnest Money Deposit amount of Rs. 10,000/- shall be forfeited in case of refusal of deposit the security deposit immediately or fails to implement the requirements of the tenders. The EMD of unsuccessful bidders/ tenderers shall be returned within 15 days. The deposit should be in favour of CIPET:CSTS, MADURAI payable by NEFT / Bank Transfer only. The Earnest Money/Security Deposit shall be adjusted against billing price of this scrap at the end.

- 7. The successful bidder / tenderer has to lift the material within 3 days after payment through NEFT / RTGS / DD/ Banker's Cheque, failing which demurrage charges of Rs. 1000/- per day will be charged up to 7 days. In case they fail to lift the material within 7 days, their tender shall be cancelled and EMD and Security Deposit paid by them shall be forfeited.
- 8. All the material has to be lifted from CIPET: CSTS, Madurai in the presence and as per instructions of the authorized person of the Institute and on the basis of Gate- Pass. The Security persons on duty at the gate of Institute will have absolute authority to stop transporting of the material in case of any doubt on checking/inspection. The Director & Head, CIPET: CSTS, Madurai will take final decision in all cases of any disputes.
- 9. The items may be splitted between the tenderers based on the highest rates offered by the tenderers. The purchaser has to arrange their own labour and transport for lifting the material from CIPET: CSTS, Madurai and has to inform CIPET: CSTS, Madurai management one working day before their intent to lift the scrap. CIPET: CSTS, Madurai management has fully right to finalize the rates and any of the tenderer has no right to involve in this matter.
- 10. The Tender shall be accepted on the basis of highest offered rates by the tenderers for each item. In case equal rates are received for an item, the items will be offered first to the tenderers who has offered highest rate in other items. If there is no tenderer who has offered highest in other items, the material will be splitted between the bidders equally. However, a bidder may withdraw his case in favour of other bidder. In this respect, the decision of CIPET: CSTS, Madurai Management will be final & binding on tenderers.
- The scrap shall be weighted on weighing Yard/ weighing machine in the presence of CIPET: CSTS, Madurai representative.
- 12. If there is any loss to the property of CIPET while lifting the scrap, the purchaser has to compensate this loss.
- 13. The Tax GST as applicable will be charged extra on the selling price.
- 14. The bidders / tender document containing the "Commercial Bid" shall be submitted in pdf format as per Annexure B only and the same should be uploaded in GeM portal.

- 15. CIPET: CSTS, Madurai reserve the right to cancel any or all items without assigning any reasons and the decision of management shall be final and binding in all cases.
- 16. The taxes (GST) & duties as applicable at the time of taking delivery by the successful bidder / bidders, which will be charged extra over the quoted bid. GST rate as applicable on scrap items Bidders should indicate their GST number while quoting).
- 17. The bidder may inspect the materials on any working day between 10:00 AM to05:00 PM between 07<sup>th</sup>December, 2022 to 20<sup>th</sup> December, 2022, except Saturday and Sunday by prior intimation through e-mail (e-mail id: \_\_\_\_\_\_) to satisfy themselves about quality & condition of the materials offered.
- 18. Quantity of items may be increased or decreased. No complaint whatsoever willbe entertained after the tenders are submitted or before or after the materials are lifted. No request for samples or inspection after submission of the tender will be accepted. In view of the :as- is -where is' condition bidders are advised to quote rates only after inspection of the items at the site.
- 19. Bidders should clearly quote their rates on per kg basis only.
- 20. BID EVALUATION: Bids would be evaluated and would be awarded to one who will offer the highest total rate for entire lot of scrap items subject to having the requisite certificates.
