CIPET: Centre for Skilling and Technical Support (CSTS), Gwalior, is an autonomous Institute established under Ministry of Chemicals & Fertilizer, Government of India. CIPET: CSTS, Gwalior invites sealed tenders in two bid system from reputed transport service provider having capacity to supply the required numbers of vehicle for a period of One year, as per details mentioned below.

SCOPE OF SERVICE

Bidders are required to Provide Hiring of vehicle service to CIPET: CSTS, Gwalior on "As and When Requirement Basis" as well as "Dedicated Vehicles on Full Time Basis" (round the clock). CSTS: CSTS, Gwalior is essentially intending hiring of 1 car on Monthly/Daily basis on contract for a period of 1 year. The number of cars required may vary based on demand. The successful bidder will be awarded the CONTRACT OF HIRING CARS SERVICE ON MONTHLY and AS & WHEN REQUIRED BASIS for 1 Year.

PERIOD OF CONTRACT:

- 1. The hiring contract shall be for an initial period of 1 (one) year & can be extended at the same terms and conditions for further period of two more Years (but one year at a time) on satisfactory performance. The extension will be sole discretion of CIPET: CSTS, Gwalior.
- 2. No price escalation is allowed during first year of contract period. However escalation of as per actual price change in fuel may be considered after 01 year during contract period extension.
- 3. The contract will be terminated by giving 15 days notice if the service is not found satisfactory or any complaint received from users.

TERMINATION:

The contract can be terminated by giving 30 days notice in writing by the contractor.

TERMS OF PAYMENT:

Contractor shall raise monthly running account bill on 1st of every subsequent month and the payment shall be made within 15 days from the date of receipt of bill month along with copy of the duly attested Log-Book.

ABOUT THE VEHICLE ON MONTLY BASIS

- 1. The Vehicle should be of 2018 onwards model with white in colour and be provided with new Batteries, tyres, tubes and upholstery at the time of placement along with the driver.
- 2. The vehicle should be well equipped with all facilities.
- 3. The Log Books for duty of the vehicles will be recorded from Institute Campus on each trip basis and records duly authenticated should be shown on demand and also to be produced with monthly bill. The vehicle with driver will remain stationed at the Institute Campus for 12 hours at the disposal of CIPET.
- 4. The vehicle(s) should be in good condition and should be provided on time. Replacement of vehicle shall be done immediately in case of repair, maintenance or any other condition with equally good condition vehicle. The service provider shall be responsible for appropriate insurance coverage. In this regard, the service provider shall maintain driver's compensation; provider shall also maintain comprehensive general liability insurance, including contractual liability coverage adequate to cover the indemnity of obligation against all damage to any property arising out of, or in Connection with, the services which result from the fault of the service provider, or its staff/driver. The service provider shall provide CIPET: CSTS, Gwalior with certification thereof upon request.

- 5. In case of any breakdown or for any other reason of the vehicle, the owner has to arrange a substitute vehicle within 01:00 hrs of time failing which penalty at the rate of 100/- per hour charges will be deducted from the bill at the discretion of the Institute. Similarly in the event of non-availability of driver due to sickness or any reason substitute driver has to be provided for theVehicles immediately.
- 6. The tenderer should ensure that the vehicle should comply with all statutory Obligations like insurance coverage, road tax, etc. together with MINIMUM OF "ALL M.P. "COMMERCIAL ROAD PERMITS VEHICLE. Before undertaking the contract.
- 7. The tenderer must be in a position to provide the vehicle within 07 days from the date of issue of Work Contract.
- 8. If the successful bidder fails to provide the vehicle in the prescribed time after the award ofcontract, CIPET: CSTS, Gwalior has full right to forfeit the Earnest Money Deposit (EMD) of the Contractor without giving any intimation.
- 9. if month hired Vehicle running is less than 2000 KM or 2500 KM , than remaining KM's will be carry forward for next month and so on.

ABOUT THE DRIVERS (Monthly Car)

- 1. **Contractor shall provide one (01) driver for each CAR.** Driver should be competent, matured and having a valid **professional (Commercial) driving license** issued by a Competent Authority with Minimum Three years experience in case of light vehicle or 1 year in case having Heavy Commercial Vehicle License. Driver should be sober, gentle, and courteous. The character and antecedents should be verified by the Police authorities. If a particular driver's performance/conduct is not acceptable to the Institute, he must be replaced immediately within 02days. In case of being intoxicated condition, indiscipline on the part of driver, he should be replaced immediately as this is life risk and detrimental to the safety of the organization.
- 2. They should always be on duty in uniform as per the colour and design decided by the Institute.
- 3. The drivers should be paid at least the minimum wages as per the Minimum Wages Act, under Govt. Rules. Besides Provident Fund facility as per statute to be provided to them. This shall be ensured by the owner and in case of any complaint regarding non compliance of any statutory Payments, the same shall be deducted from the bill without prejudice to theInstitute's right to cancel the contract.

GENERAL CONDITIONS OF THE CONTRACT FOR HIRING VEHICLE:

- 1. Prices/Rates should be quoted only in the "Annexure- II" in the manner asgiven therein. Rates/offer given in any other manner will not be accepted.
- 2. The monthly Hire charges shall include all cost of maintenance and Servicing, Mobile /Engine oils and other lubricants, wages and others Benefits of the drivers, as per

requirement of the Institute, Road taxes, Permits, Insurance, all statutory payments for driver and vehicles, etc.

- 3. Toll Tax and parking charges (if any for outside duty) may be reimbursed to the contractor along with settlement of monthly bill on production of slip Like Parking, Toll Tax, State Tax etc.
- 4. The Car/Vehicle and driver must be produced for inspection before and only this approved car and driver must be provided every day to the Institute.
- 5. In case of change of regular vehicle substitute vehicle provided must be in Compliance with all rules and regulations as applicable and if on Verification this is not found to be true then a penalty of Rs. 500 per day will be charged and vehicle will not be treated as on official duty for this Period. Similar condition applies for substitute driver. In the case of same Situation continuing for 3 days, the contact will be terminated.
- 6. The Bidders are required to submit their offer in two parts (**Technical Bid as per Ann. I** & **Financial Bid as per Ann. II**)

Cover - 1 (Technical Bid) shall be superscribed as "Technical bid" duly indicating the Tender Reference no. which should contain the details as per "Annexure I", EMD of **Rs.5,000/ (Rupees Five Thousand Only)** in the form of Demand Draft drawn in favour of **CIPET -VTC, Gwalior** and cost of Tender document/ Money receipt for amount paid towards cost of tender document. The technical bid without EMD & Tender Fee stands cancelled.

Cover 2 (Financial Bid) should contain Price only and shall be superscribed as "Financial bid' duly indicating the Tender Reference No. as per "Annexure II "

Cover 3 (Technical and Finance Bid) both the cover should put in to Cover 3 and shall be superscribed as "Technical bid and Financial bid" duly indicating the Tender Reference No.

7. Security Deposit: The tenders whose tenders have been selected have to Deposit the Security Deposit of Rs. 20,000/-(Rs. Twenty Thousand only) in the form of Demand draft drawn from any Nationalized Bank in favour of **CIPET VTC**, **Gwalior**, shall be deposited within 07 days from the date of issue of order and the entire security amount shall be retained till the successful completion/execution of the work order. Institute reserves the right to forfeit this security deposit if party fails to comply any provision or violates any terms and conditions of the contract and no correspondence will be entertained in this regard. No interest will be paid by CIPET on Security deposit to the contractor.

DUTIES AND RESPONSIBILITIES OF CONTRACTOR

1. PROVISION OF STAFF: The contractor shall provide, at his own cost, trained Drivers having valid license and other employees with necessary tools, Instruments, equipment etc., for the safe, effectiveand efficient discharge of the work contemplated in the contract.

- 2. The contractor shall provide, at his own cost, all employees with necessary Identity cards/license, uniforms, mobile phone which theyshall display on their Person to distinguish them from unauthorized persons.
- 3. Contractor shall be responsible for the proper and orderly conduct ofhis staff/workers while performing their duties as a part of this Contract and shall employ only such persons whose character hasbeen verified by the police/ the Govt. Administrative Officer. He shall, on demand, produce papers regarding Police verification of any of his staff.

Other Terms & Conditions:

- 1. The successful bidder shall not Subcontract, transfer or assigns the task to any other agency without thePrevious written approval of CIPET: CSTS, Gwalior.
- 2. In case of the absence of Driver, agency has to provide the substitute Driver. If the agency fails to provide the substitute of Driver/Vehicle, a Penalty @ 2 times per day on the hiring cost of the vehicle shall be imposed.
- 3. The Tenderer shall provide vehicles as per requirement of the Institute and As and when required even at a short notice.
- 4. The Agency submitting the Tender would be presumed to have considered and accepted all the terms & conditions of this tender. No enquiry, verbal orwritten shall be entertained in respect of acceptance/rejection of tender. The transport agency must haveProvided similar service to Govt. organizations of equal statute.
- 5. Vehicles shall be used for the Inter State travels, if required.
- 6. The Contractor has to provide GST & PAN number
- 7. If the successful bidder fails to provide the vehicle in the prescribed time after the award ofcontract, CIPET: CSTS, Gwalior has full right to forfeit the Earnest Money Deposit (EMD) of the Contractor without giving any intimation.
- 8. The bid received after the specified date and time will not be considered.
- 9. Vehicles shall be under the control of CIPET: CSTS, Gwalior during the contract period except for the duration it goes for regular maintenance (only one day per month) after taking Permission from the concerned authority and shall not be used by the contractor for any other personal purpose.
- 10. The bidders have to submit the Work Orders & Performance Certificates/Satisfactory Services certificates for evaluation purpose.
- 11. The Contractor shall provide valid certificate of pollution check for the vehicle from the concerned authorities and the same shall be renewed well before the due date.
- 12. TDS will be deducted at source from hiring bill/s as per the Income Tax Act.

- 13. No advance payment would be made. During the period of contract, the rates will not be revised.
- 14. All vehicles shall be insured against all risks (including the driver and occupants). Insurance policy shall be renewed well before the due date.
- 15. Driver should always carry all necessary documents like Registration papers, Insurance papers, PUC clearance, RTO tax payment papers, valid driving license and all other documents as per rules & regulations of Government of India.
- 16. Lodging, boarding, transportation of drivers shall be the contractor's responsibility.
- 17. If the successful bidder fails to provide the vehicle in the prescribed time after the award ofcontract, CIPET: CSTS, Gwalior has full right to forfeit the Earnest Money Deposit (EMD) of theContractor without giving any intimation.
- 18. The CIPET- GWALIOR will have full authority to reject any/all offers without assigning any reasons. Any enquiry after submission of the tender will not be entertained.
