### **Instructions and Conditions**

- 1. All the rates shall be filled up in figures as well as words in the Schedule of Rates to be quoted by the bidder as given at page no. 9 to 11 of the Tender Document in English language only without fail. In case of variation, higher of the amount quoted in words and figures will be accepted as final bid/quote.
- 2. The rates and amount against each item shall be filled up only in the tender form issued to the tenderers.
- 3. The tenders shall be accompanied by the EMD for the specified amount.
- 4. The tender document (all pages) shall be duly signed and stamped with firm's seal by the bidder.
- 5. No paper sheet shall be detached from the tender document.
- 6. The tender shall be liable for rejection if any of the above said requirements are not complied with.
- 7. Period of sale of tender forms **from 15.02.2023 to 28.02.2023** between office hours (9:00AM to 5:30PM).
- 8. Quotations below MRP (minimum reserve price) shall not be accepted.
- 9. EMD for the purpose of this tender document has been fixed as **Rs. 35,000/- (Rupees Thirty Five Thousand only)** and the amount shall be paid through demand draft drawn on any Nationalized Bank favoring CIPET Murthal payable at Murthal. The same shall be submitted by bidder along with the tender document. The tender not accompanied with the full value of prescribed EMD and in the format prescribed will be summarily rejected. Late tenders will not be accepted. EMD does not bear any interest and will be returned to unsuccessful Bidder.
- 10. The bidder shall clear the material out of the premises at its own arrangements/ cost, etc.
- 11. All the intending bidders may inspect the scrap put up for disposal during the working hours of the institute. In any case it will be presumed that they have inspected, verified and satisfied themselves about the material before quoting.
- 12. Bidders can bid for any one or more categories of material. However, the bidder quoting highest bid for any one or more than one item shall be required to lift the entire quantity of material in r/o which his bid has been found highest.
- 13. Tender may be quoted in full or part on item wise basis. Quantities of Scrap may be divided equally among Parties quoting same rate for same item at the discretion of CIPET: IPT, Murthal.
- 14. The highest bidder shall lift the material from the premises after payment of full amount within the prescribed time limit, failing which they will cease the right to lift the material and the payment deposited shall stand forfeited.
- 15. In case the party quoting the highest bid for any item(s) does not lift those of the item(s) for which it has quoted the highest bid within stipulated time, then WHOLE EMD OF THE PARTY SHALL BE FOREFITED & right of party to lift those item(s) in the capacity of highest bidders shall stand cancelled.
- 16. The tender will be rejected if the rate is not above the MRP (minimum reserve price) as decided by the competent authority.
- 17. CIPET: IPT Murthal reserves the right to reject / partly accept, any or all offers without assigning any reasons whatsoever.
- 18. The sale of items shall be on the basis of the highest rates quoted for each item subject to other conditions stipulated in tender documents. Based on the highest offer for individual items, sale shall be made separately for each item to the highest bidder.
- 19. CIPET: IPT Murthal shall issue work order to qualifying bidder(s) quoting highest bids to lift the item(s) for which their bid has been found to be highest. All such bidders to whom work

order has been issued by CIPET to lift items, shall deposit amount; calculated by multiplying the approx weight of item put for disposal and the highest bid quoted by the particular bidder; within 7 days of issue of work order in Account Department of CIPET: IPT Murthal, failing which the entire EMD of such bidder shall be forfeited beside the highest bidder losing his right to lift the item(s) for which his bid has been found to be highest; and CIPET: IPT, Murthal shall be free to offer it to the next highest bidder or to cancel the tender for that item only. The final adjustment of amount to be actually paid by the highest bidder in r/o items for which Work Order has been issued to him shall be based on actual weight of items, for which Gate Pass has been issued. In no case; any credit shall be extended to highest bidder for removing the items from CIPET premises as per work order issued to him.

- 20. The material shall be lifted on the basis of actual measurement of weight taken in the presence of the representative of CIPET: IPT Murthal at any weighbridge outlet identified by CIPET: IPT Murthal.
- 21. The bidder has to settle all the payments before issuing of Gate Pass.
- 22. Taxes at rates as applicable will be charged extra on the total amount calculated as per clause no. 19, of the scrap material in r/o which work order has been issued to him.
