CIPET: IPT, Ahmedabad invites online bids through tender from Scrap Dealers, Individuals and others who are interested in buying Ferrous, Non-Ferrous, Plastic, Wood & Other Scrap items which are lying as and where within the campus. Interested vendors may also inspect the scrap items from 10:00 AM to 01:00 PM from 10.09.2020 to 28.09.2020

B)	Procedure for quoting price	The offer price shall be quoted for each category of the scrap item as per Annexure A in Kilo Gram (KG's)/Liters for liquid item. The tender shall be awarded based on the highest offer received for individual item/stock. In other words, the successful bidder would be decided for each item based on the highest offer received for particular item. 100% advance payment with applicable GST (18% approx) as per scrap item has to be paid to CIPET: IPT, Ahmedabad. In addition, Tax Collected at Source (TCS) has to be paid at the rate of 1% of the total value of scrap. The taxes are applicable as per Government of India directives.
C)	Earnest Money Deposit (EMD)	Rs.10,000/- (Rupees Ten Thousand only). The EMD will be refunded in case of non-acceptance of tender. Further EMD of successful Tenderer/Bidder will be forfeited in case of his refusal to honor the contract of Sale/Disposal of

		Scrap on any grounds post award of contract of Sale/Disposal.
D)	Cost of Tender Documents	Rs.500/- (Rupees Five Hundred Only) Non refundable.
E)	Scrap Lifting Time	Within 15 days from the date of awarding the order. Thereafter penalty at the rate of Rs. 100 fixed will be charged per day for noncompliance till 30 days and their after work order stands cancelled.

2. The cost of Tender Document of Rs.500/- should be enclosed in form of Demand Draft drawn through any nationalized bank along with the duly filled Tender document.

3. Principal Director & Head, CIPET: IPT, Ahmedabad reserves the right to accept or reject any or all tender wholly or partially without assigning any reason whatsoever. The decision of the Principal Director & Head, CIPET: IPT, Ahmedabad shall be final and binding on the bidder with respect to this tender for Sale/Disposal of Scrap.

The plastic and other scrap items, etc are listed below with the tentative quantity, it may increase or decrease subject to the availability at site:

1. PVC Pipe – 11,000 KG
2. HDPE Pipe – 4,000 KG
3. Broken Plastic Tank – 1,600 KG
4. Brass Wire Waste – 100 KG
5. Mix Metal Chips – 100 KG
6. Plastic Mix Scrap – 2,600 KG
7. Scrap Papers – 500 KG
8. Mix Waste – 2,400 KG

## **INSTRUCTION TO THE TENDERER**

The Tender shall be submitted in accordance with the instructions and any tender not confirming the instructions is liable to be rejected.

1. The Tender Fee & EMD should be submitted in sealed cover superscribed as “**SALE/DISPOSAL OF SCRAP**” to the office of the Principal Director & Head, CIPET: IPT, Ahmedabad.

2. The EMD (Demand Draft) to be drawn through any nationalized bank in favor of “CIPET” Payable at Ahmedabad. The EMD of the unsuccessful bidders will be refunded after 15 days and of the successful bidders will be refunded after 30 days on completion of the tender process/award of work order.

3. The tender should be complete in all respect and should be signed with date by the Authorized Signatory of the firm on all the pages.

4. The offer price shall be quoted for the scrap on per KG and liter basis for liquid item and applicable taxes/GST/TCS shall be extra as per Government of India norms from time to time.

5. The Tenderer/bidder is free to inspect the Scrap at CIPET: IPT, Ahmedabad, Plot No. 630, Phase-IV, GIDC, Vatva, Ahmedabad-382445 from 10.00 AM to 01.00 PM on any working day from Monday to Friday (10.09.2020 to 28.09.2020) in presence of CIPET: IPT, Ahmedabad Officials.

6. The tender shall **be awarded based on the highest rate received** for individual item/stock. In other words, the successful bidder would be decided for each item based on the highest rate received for particular item.

7. **Procedure for disposal of Scrap:** The successful Tenderer shall deposit a lump sum amount in Rupees for individual category of scrap item by way of Bank Deposit/Demand Draft in favor of CIPET payable

at Ahmedabad towards the cost of Scrap (approx) within three working days from the date of award of the work order.

8. It may be noted that 100% advance payment has to be paid for lifting of the Scrap items from CIPET: IPT, Ahmedabad.

9. The truck/tempo used for Scrap lifting and carrying to the respective destination of the bidder shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap on truck/ tempo at their own cost and CIPET: IPT, Ahmedabad will not pay any charges for the same.

10. Prior to the loading of scrap on the Truck/Tempo, the empty Truck/Tempo weight shall be taken to the Weighing Bridge (Dharam Kanta) for weighing in presence of official from CIPET: IPT, Ahmedabad. The charges for the same will be borne by the bidder.

11. After loading the scrap, the loaded truck would again be sent to the weighing bridge (Dharam kanta) for weighing and the weight of material will be calculated based on the quantity of scrap and price quoted by the bidder. The Weighing Bridge will be decided at random by concerned CIPET: IPT, Ahmedabad official. The billing will be done as per the actual quantity and price of the scrap item. The bidder may also deposit the 100% amount in advance in CIPET Ahmedabad's designated bank account as per the actual quantity and price of the respective scrap item.

12. CIPET: IPT, Ahmedabad will not accept any payment in Cash for sale of scarp.

2. Earnest Money Deposit (EMD) will be refunded by CIPET: IPT, Ahmedabad on completion of tendering process without any interest.

3. I/We agree that the price quoted in 'Offer format' as enclosed as per Annexure-A is excluding of taxes, duties and other government levies.

The applicable taxes/GST/TCS shall be extra on sale of scrap at CIPET: IPT, Ahmedabad as per Government of India norms.

4. I/We shall have to make all arrangements for loading of scrap to truck/tempo at our own cost. Also I/We shall bear the cost of both weighing (empty and loaded) the Truck/Tempo at the weighing bridge (Dharam Kanta) as selected by CIPET: IPT, Ahmedabad official.

5. I/We agree to lift the whole lot of scrap and not a part thereof failing which The Principal Director & Head, CIPET: IPT, Ahmedabad will be at a liberty to forfeit EMD deposited by me and impose penalty of Rs. 100/- on per day basis for noncompliance till 30 days and their after work order stands cancelled.

6. All responsibility related to any taxes as applicable will be of the successful Tenderer/bidder. CIPET: IPT, Ahmedabad shall not be responsible for the same.

7. The scrap is being sold on the assumption that the Tenderers have inspected the items at CIPET: IPT, Ahmedabad and know what they are buying and the principles of "CAVEAT EMPTOR" shall apply and no reliance must be placed on description of the Scrap.

8. In the event of any dispute, the legal matter shall be subjected to the jurisdiction of Ahmedabad Court only and the language of communication shall be English only.
