### **SPECIAL TERMS AND CONDITIONS / INSTRUCTIONS TO BIDDER**

1. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required for the Tender Documents or submission of a Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer's risk and may result in rejection of the Tender.
2. The purchaser shall not be liable for any expenses whatsoever incurred by the Tenderer in the preparation of the tender whether his tender is accepted or not even if the purchaser opts for complete withdrawal of invitation of Tender.
3. The Tenderer is advised in his own interest to examine the present CIPET uniform at institute premises before submission of the bid.
4. Measurement of Uniform must be taken at CIPET CSTS Hyderabad premises as per the details provided by CIPET Authority or as per the readymade sizes provided by CIPET as per the instructions provided in the Purchase Order.
5. Supplier shall be solely responsible for any defect in stitching, quality of material etc. which may result in poor quality.
6. One set of Stitched Uniform along with details of fabric used shall be submitted with suitable packing along with the Technical Bid.
7. The label indicating the size of uniform shall be clearly indicated on the packet.
8. Documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre - qualification criteria.
9. Offer should be in two parts Viz., "TECHNICAL BID" and "FINANCIAL BID" and all bids must be submitted through the online portal [www.tenderwizard.com/CIPET](http://www.tenderwizard.com/CIPET).
10. Any Tender received by the Purchaser after the deadline for submission of E-Tenders prescribed by the Purchaser, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
11. Tenders shall remain valid for 180 days after the date of E-Tender and incase of Rate Contract it should be valid for 1 year.
12. The work should be completed within 20 days time from the date of issue of the Purchase Order / Work Order.
13. In case of non receipt of stitched uniform in all aspects as per the requirement within 20 days from the date of issue of the Purchase Order / Work Order CIPET:CSTS, Hyderabad has the right to charge liquidated damages @ 0.50% per week subject to maximum of 10% of the total purchase value.
14. The cost of tender document is Rs. 1,000/- (Non Refundable) and Tenderers are requested to submit the tender fees on or before 25.09.2020, 3.30pm, by way of Demand Draft drawn in favor of "CIPET Hyderabad" payable at Hyderabad, failing which the tenders of that party will be rejected.
15. The Tenderer shall pay Earnest Money Deposit of Rs. 10,000/- in the form of Demand Draft drawn in favour of "CIPET Hyderabad" payable at Hyderabad on or before 25.09.2020, 3.30 PM. The tenders received without the EMD shall be rejected. The Earnest Money of the unsuccessful Tenderers will be refunded after 15 days time from the date of completion of tender process.
16. EMD amount of successful bidder shall be kept as performance security for a period of 60 (sixty) days to be reckoned from the date of receipt of goods in all respect and on completion of the Validity of 180 days from the date of issue of PO.
