- 2. The EMD (Demand Draft) to be drawn through any nationalized bank in favour of "CIPET" Payable at Ahmedabad. The EMD of the unsuccessful bidders will be refunded after 15 days and of the successful bidders will be refunded after 30 days on completion of the process/award of work order.
- 3. The bidder should be complete in all respect and should be signed with date by the Authorized Signatory of the firm on all the pages.
- 4. The offer price shall be quoted for the Item/Machine. The applicable taxes/GST/TCS shall be extra as per Government of India norms from time to time.

- 6. The bidder shall **be awarded based on the highest rate received** for Item/Machine. In other words, the successful bidder would be decided for Item/Machine based on the highest rate received for particular Item/machine.
- 7. **Procedure for disposal of Machine**: The successful bidder shall deposit a lump sum amount in Rupees for obsolete Item/Machine by way of Bank Deposit/Demand Draft or deposition of cash in accounts department of CIPET:IPT, Ahmedabad. The DD is payable at Ahmedabad towards the cost of Machine (approx) within three working days from the date of award of the contract work order.
- 8. It may be noted that 100% advance payment has to be paid for lifting of the Machine from CIPET: IPT, Ahmedabad.
- 9. The Truck/Tempo used for Machine lifting and carrying to the respective destination of the bidder shall be arranged by bidder at their own cost. The bidder shall have to make arrangement for loading of Machine on Truck/Tempo at their own cost and CIPET: IPT, Ahmedabad will not pay any charges for the same.
- 10. Prior to the loading of Machine on the Truck/Tempo, the empty Truck/Tempo weight shall be taken to the Weighing Bridge (DharamKanta) for weighing in presence of official from CIPET: IPT, Ahmedabad. The charges for the same will be borne by the bidder. The allotted plant and Machine can be lifted in presence of CIPET officials through gate pass system.
- 11. After loading the Machine/Item the loaded Truck would again be sent to the weighing bridge (Dharam kanta) for weighing. The Weighing Bridge will be decided at random by concerned CIPET: IPT, Ahmedabad official. The billing will be done as per the actual allotment of Machine/Item. The bidder may also deposit the 100% amount in advance in CIPET Ahmedabad's designated bank account as per the actual quantity and price of the respective Machine/Item.
