02. Scope of Work:

Scope of Work includes the following:

Supply & Installation of Grill surrounding Glass Windows at New Campus of CIPET: CSTS-Agartala:

Supply & Installation of Iron Grill to be made with standard Iron bars with painting as per the requirement of CIPET: CSTS-Agartala. Total area of measurement is approx **7,000 sqft.** Bidders are advised to visit the site physically and attend **pre-bid meeting** on **27-08-2020** to get clear idea and exact requirement. The amount quoted by the bidders should be inclusive of painting charges, other necessary material and includes Labour charges.

03. Qualification Criteria/ Eligibility Condition of the Bidder:

01. The bidder shall have **Past one years' experience** in the same field. Experience proof needs to be enclosed.

02. The bidder shall have completed **one work** of the similar nature, value of each Contract should not be less than **Rs. 05 lacs.** Copy of Work Order and satisfactory performance certificate is required to be enclosed as proof of experience.

03. Turnover of the bidder from the similar type of work should be minimum **05 lacs for past Three Financial Year.** Copy of Income Tax Return/ Audited Statement of Profit & Loss and Balance Sheet needs to be attached.

04. Performance Security

Within 21 days after the Supplier's/contractors receipt of Purchase Contract/Work Order, the Supplier/Contractor shall furnish performance security to the Purchaser for an amount of **5% of the contract value** valid up to 60 days after the date of Completion of performance Obligations including warranty obligations, if any. Performance Security should be in the form of DD/BG valid till 60 days after the date of Completion of performance Obligations including warranty obligations. DD should be in favour of **"CIPET AGARTALA VTC"** payable at Agartala, Tripura.

The performance security will be discharged by the Purchaser and returned to the Supplier not later than 60 days following the date of completion of the Supplier's performance obligations, including any warranty obligations, under the Contract. Performance Security will be

forfeited in case of suppliers default to perform the contract as per as per Work Order.

05. Warranty/Guarantee:

The Contractor warrants that the Goods supplied under this Contract are new, unused materials unless provided otherwise in the Contract. The Contractor further warrants that the Goods supplied (Iron Grill with painting) under this Contract shall have no defect from design, materials or workmanship (except insofar as the design or material is required by the Purchaser's Specifications) or from any act or omission of the Contractor, that may develop under normal use of the supplied Goods in conditions obtaining in the country of final destination. **The warranty period is 12 months from the completion of the entire work and obtaining completion report from CIPET: CSTS-Agartala.** The Contractor is liable to pay all damages / defects due to bad workmanship or supply of inferior items / material to CIPET. In that case the performance Security is liable to be forfeited.

06. Payment:

Payment of contract shall be made the following manner:

01. Payment will be released with 30 days after Completion of entire work and submission of GST Invoice along with Work Completion report from CIPET Agartala.

07. Penalty Clause:

In case of deficiency in Service, CIPET Agartala will arrange the service from other Service Provider at the cost of the Contractor. The amount will be recovered from the pending bill of the contractor.

08. Completion Period & Liquidated damages:

The entire work shall be completed with 30 days from the date of issue of Work Order. Failure to complete the above work with 30 days as above will attract liquidated damages equivalent to 0.5 percent of the delivered price of the delayed goods or unperformed services for each week of delay until actual delivery or performance, up to a maximum deduction of Max of 10% of the delayed goods or services Contract price. Once the maximum is reached, the purchaser may consider termination of the contract.

09. Resolution of Disputes:

The dispute resolution mechanism to be applied shall be as follows:

01. In the case of a dispute or difference of opinion arising between the purchaser and contractor relating to any matter arising out or connected with this agreement, such dispute or difference of opinion shall be referred to Dy. Director & Head, CIPET: CSTS-Agartala.

02. The Indian Arbitration Act 1940, the rules there under and any statutory modification or re-enactments thereof, shall apply to the arbitration proceedings.

03. Only Court of Agartala shall have the jurisdiction in any legal proceeding arising in the Contract.
