- 1. - 2. In case Tender Document is downloaded from web site, the cost of Tender Document i.e Rs.590/- including GST should be enclosed while submitting the duly filled-in Tender by way of Demand draft/Pay Order in favour of **"CIPET VTC Vijayawada"** payable at Vijayawada.

- 6. The period of contract is initially for a period of year from the date of issue of the work order/entering of MoU. The same shall be extended for an year or for a further period as decided by the competent authority with mutual consensus. If CIPET: CSTS, Vijayawada intends to terminate the contract, one month notice shall be given and if the contractor intends to terminate the contract, three months notice shall be given. And if the contractor terminates the contract within the contract period, the submitted performance guarantee shall be forfeited or as decided by the competent authority.
