INTRODUCTION

Tenderer's shall submit their bids in Two-bid system wherein, the Tenderer's shall fill the Technical bid and Financial bid separately with super scribing the details on the envelope and they shall be kept in separate sealed envelopes and both the envelopes shall be kept in another sealed cover super scribed as "Tender for Hiring of Transit office cum Guest House" to this office on or before 08.03.2022 up to17.00 Hrs.
- 6. The period of contract is initially for a period of year from the date of issue of the work order/entering of MoU. The same shall be extended for an year or for a further period as decided by the competent authority with mutual consensus. If CIPET: CSTS, Vijayawada intends to terminate the contract, one month notice shall be given and if the contractor intends to terminate the contract, three months notice shall be given. And if the contractor terminates the contract within the contract period, the submitted performance guarantee shall be forfeited or as decided by the competent authority.
- **7.** Any Tender received after the last date for submission prescribed in the tender, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
