## **Essential Requirements for the tender**

## 1. Minimum Eligibility of the suppliers

- a) Suppliers / manufacturers should have minimum three years of experience of tailoring / stitching of official uniforms in bulk to the Departments / Ministries of the Government of India / PSUs / Corporates / Engineering Colleges / Schools, etc. (Three copies of work orders received during each of the last two years should be enclosed).
- b) Should have minimum turnover of Rs.7 lakhs per year during each of the last two years (valid and certified proof has to be attached)

## 2. Tender Prices

a) The rates / prices should be quoted in Rupees (INR) only in words as well as in figures. Taxes, if any, should be indicated separately. No additional freight charges will be paid.

## 3. Submission of Tender

## I. Sealing, Marking & Submission:

- a. Envelope No.1shall contains Declaration (Annexure I) and Vendor Registration Form (Annexure II) with all the required supporting documents. A covering letter may also accompany the same.
- b. Envelope No.2 shall contains the samples of accessories i.e. cloths for pants & shirts, thread, lining, zip, inter-lining, fuse lining, pad, chest piece, buckram, buttons / (Samples of unsuccessful Supplier / manufacturers may be returned back).
- c. All the above two envelopes are packed in a third Envelope (packed and marked) and addressed to CIPET: IPT, Kochi and must reach on or before the 30.04.2021 by 03.00 p.m.
- d. All the above envelopes shall bear the Name of the Work viz. "TENDER FOR SUPPLY OF STITCHED UNIFORMS".
- e. All the envelopes shall indicate the name and address of the Supplier / manufacturer to enable the tender to be returned unopened, if required.

## II. Mode of Payment

a) Payment against Bill / Invoice shall be released only after execution / supply of the uniforms as per specification and submission of the Bill / Invoice through A/c Payee Cheque / NEFT payment only.

- b) The measurement for stitching the uniform of eligible students shall be taken for by the tailoring firms themselves in the CIPET: IPT, Kochi on day / days so fixed by the competent authority.
- **III.** CIPET: IPT, Kochi will inform the requirement of uniform based on the actual requirement.
