TERMS AND CONDITIONS

The bidder has to supply the Aluminium Raw Material within 10 - 15 days from the date of award of Purchase order issued by CIPET:CSTS, Bhopal. 13 Tons quantity should be supplied in 03 phases of 4 tons each for first 2 phases and 5 tons in last phase of supply after every 02 months as per requirement & schedule specified in purchase order. Vendor should submit raw material testing certificate of above grade Aluminium material sample tested at NABL accredited metallurgical laboratory along with each delivery.
4. Vendor should submit the Aluminium round bar sample of above grade & dimensions (1 No) for trial and approval purpose while submitting the quotation. After successful trial and approval of sample, the purchase order will be issued as per the CIPET purchase procedure to L1 party/vendor.
5. In case of supply not completed satisfactory or in case of delay, CIPET Bhopal reserves the right to forfeit the EMD and charge penalty as decided by CIPET Bhopal's management. The decision of CIPET Bhopal's management shall be final in all matters and binding on the bidder. Late delivery clause will be applicable at 0.5 % per week, If the item is not supplied within the stipulated delivery scheduled mentioned in P.O.
6. If the supplied material is rejected due to non-conformance with technical specification requirement as per tender documents by the CIPET officials after receipt of the material, then the supplier should replace the material by their own cost or refund the material cost to CIPET.
7. The bidders shall indemnify CIPET : CSTS, Bhopal against any payment and for non-observance of the Contract Labour (Regulation & Abolition) Act' 1970.
8. The payment will be paid within 20 days after successful completion of work. The bidder has to get the completion report duly authorized by the Head of the Tool Room department for processing of the bill.
9. TDS (Tax Deducted at Source) and any other applicable tax shall be deducted as per prevailing rules and regulations of the Government of India, if applicable.
