ELIGIBILITY AND SELECTION CRITERIA

1. A registered company, firm or agency having:
 - a. Experience of at least Three Years in providing the Transportation Services in any Govt./Semi-Govt./Central Autonomous bodies/company any other organization.
 - b. Minimum average Annual Turnover of Rupees 15 Lakhs and more only for Transportation Services during the last three financial years
2. The Tenderer should be registered should have PAN and GST registration,
3. The Tenderer shall have well established office in Aurangabad since last 3 years and having client in Aurangabad (Enclosed the Proof of establishment and client list).
4. The Tenderer should not have been blacklisted by any Govt./Semi-Govt./Central Autonomous bodies/any other organization.
5. The Tenderer must submit duly filled Tender form specified in Annexure 2 to 5 (as Technical Bid) of this document.
7. Certificate of registration, MOU in case of partnership firm, article of association etc shall be attached.
8. The Tenderer submit Work Done Certificate/ Work Order on letter head of client for last 3 Year for Turnover and carried Transportation Services contract.
9. The Tenderer without the qualifications as mentioned at Sl. No.1 to 8 above and Tender without all the required documents shall be rejected. Tenders incomplete in any form are liable to be rejected out rightly.
10. Canvassing in any form is prohibited and the tenders submitted by the contractor who resort to canvassing are liable for rejection.
11. In case any person sign the tender/agreement on behalf of a limited company or firm, letter of authority/resolution passed by the company /firm empowering him/her to sign the documents on behalf of company or firm shall be enclosed in the tender document.
12. CIPET: CSTS, Aurangabad does not bind himself to accept the lowest tender and reserves the right to accept or reject, in part or full, any or all the tenders received without assigning any reasons.

Special Terms & Conditions

1. The transporter shall make available the trucks and lift the consignment within 6 hours of intimation by CIPET Aurangabad.
2. It shall be ensured that the entire consignment under the agreement is lifted within the dates intimated by CIPET Aurangabad on each occasion. If the transporter fails to lift the stocks within 6 hours of CIPET Aurangabad's intimation, CIPET shall have the right to impose a penalty for delayed lifting at the rate of two percent of the freight charges per day per truck up to a maximum of three days beyond which it shall be open to CIEPT to transport the goods through any other transporter.
3. If CIPET has to pay more than the amount payable to the transporter under this contract, the excess amount paid shall be recovered/adjusted by CIPET from the amount and/security deposit at the credit of the transporter.
4. The receipt from the other transporter for payment by CIPET on account of transporting the goods through them shall be conclusive evidence of the amount so paid and the transporter under this contract shall without any dispute pay the excess amount either in cash/accept recovery /adjustment from the amount at his credit.
5. The consignment shall be delivered by the transporter at the consignees address at the specified destination on door delivery basis during office hours i.e. 10.00 hours to 17.30 hours, on working days
6. If delivery outside office hours or on holidays is anticipated, the transporter shall inform the consignee, in writing, at least 6 hours in advance above such delivery to enable the consignee to make the required arrangement. However, neither the consignee nor the consignor shall be responsible if arrangements are not made by the consignee for taking delivery of the consignment after the office hours or on holidays.
7. Octroi and toll tax, if any paid by the transporter will be reimbursed by the consignor on production of the relevant receipts only on normal rates without penalties. CIPET will however not make any separate payment on account of insurance if arranged by the transporter. The payments towards freight charges shall be made on to be billed basis.
8. No detention charges will be payable for the first 24 hours of detention of trucks at the originating station or at the destination station. For detention beyond 24 hours, CIPET may pay detention charges @ Rs.400/- per day
9. The transporter shall not withhold the delivery of the consignment for any reason whatsoever, and shall be solely responsible for any loss that CIPET may sustain on account of such non delivery. In the event of non delivery of the consignment at the destination the transporter shall bear the entire cost of the material.
10. No transshipment is allowed in between the destinations. For any reason such as breakdown, accident etc. if the truck is stranded beyond reasonable limits, the transporter should make alternative arrangements for safe transportation of the goods by road within the delivery time limit prescribed already. Except the extraordinary justifiable situation such as accident, breakdown, road blockage etc. no transshipment is allowed i.e. the truck received by the consignee should be the same as that into which the stock was loaded by the consignor as indicated in the

LR. If and when transshipment is resorted to and the truck No. is changed, the transporter shall justify the same to CIPET's satisfaction. For delay/damages on account of transshipment not accepted by CIPET, penalty shall be twice the penalty prescribed for normal delay / damages.

11. No endorsement shall be made on the LR/GC to the effect the consignment is carried at the "owner's risk" and it should be on "Carrier's Risk" only.
12. Due to hike or decrease in the rates of fuel escalation will be considered only increasing the rates more than 10% and minimum after period of six months. Hike will be vice versa \pm . In such cases percentage for increase or decrease will be governed @ 5% only.

Terms and Conditions

1. Period of Contract: The contract period will be initially for a period of One Year extendable on satisfactory performance and mutual consent on same terms and conditions to twice each time for One Year and/or it can be terminated by the Director & Head by giving one month notice to the agency.
2. Tenders received without prescribed Tender fee & Earnest Money Deposit (EMD) shall not be considered.
3. Bidder register under Micro & Small Enterprise (MSEs) as defined in MSE procurement policy issued by department of MSME or register with central purchase organisation will be considered for relaxation of EMD and Tenders Fees.
4. Agencies must have its own local Office in “Aurangabad” & in this office there must be minimum 2-3 staff who can handle the problem related to Security.
5. The received bids will be evaluated by the Committee of CIPET: CSTS, Aurangabad on the basis of requisite documents. There after a team of CIPET will visit the site for physical inspection of the site and if found suitable and meeting the requirements of CIPET: CSTS, Aurangabad as indicated in these terms & conditions the financial bid will be open for technically qualified bidder.
6. CIPET: CSTS, Aurangabad reserves all rights to accept or reject in part or full any or all the offers without assigning any and/or to withdraw/relax any of the terms and condition mentioned above so as to overcome the problem encountered at a later stage
7. The period of contract shall be initially for Eleven months, & can be terminated by the Director & Head by giving one month notice to the agency.
8. The bill shall be submitted by the Transport Agency in duly supported by proof of Delivery Memo
9. The rates and prices toward the service charges quoted by the bidder shall be fixed for the whole duration of the service contract and shall not be subject to adjustment on any account.
10. The tenderer shall have to execute an agreement with CIPET: CSTS, Aurangabad on a Non Judicial stamp paper of Rs.100/- after issue of work order.
11. The successful tenderer/agency shall not engage any sub-agency or transfer the contract to any other person/firm/agency in any manner. The agency shall not be permitted to transfer their rights and obligations under the contract to any other person/organization or otherwise.
12. The payment for the services rendered would be paid within 10 days from the date of receipt of invoice.
13. The charges as mutually agreed upon would be followed for the entire period of the agreement and the contractor shall not make any claim or additional charges other than expressly agreed to in this agreement.
14. TDS and GST on TDS as applicable shall be deducted from the monthly bill of the agency.
15. The agency selected should follow the instructions given by the management of CIPET from time to time and in case of violation of the instructions, the agreement can be cancelled without any reference or notice.

16. CIPET reserves the right to consider/reject any or all tenders the tender process without assigning any reasons/notice. The management decision in this regard will be final in all respect and shall be binding on the Tenderer.
