  - a. Document Fee – Rs. 100/- (inclusive -GST) should be submitted along with Financial bid.
  - b. EMD Deposit – Rs. 5000/- (should be submitted along with Financial bid).
3. Sealed Quotation shall be submitted by regd. Post/Speed Post or can be dropped in the sealed box available in the office of Administration Department, CIPET: CSTS, Amritsar.
4. The Intending Bidders or his authorize representative may inspect the scrap materials etc. lying in the stores/space provided for this during the office hour on any working days between 3.00 PM to 4:30 PM from **19.06.2020 to 06.07.2020**. With permission of the authority, if they so desire before offering their rates against the lot.

5. **After finalization of the auction sale, the successful bidders shall have to pay the deposit 50 % of bid amount immediately against Sale order apart from EMD deposit and the balance leftover payment of 50% amount with GST as applicable against final tax invoice before lifting the materials.**
6. **GST as applicable on the Quotation of the material shall be levied of the successful bidders over and above the bid price.**
7. If he fails to deposit the full amount within 4 days (Four days from the date of bid, his bid amount so deposit along with the EMD shall be forfeited).
8. The scrap items after finalization of the bid amount and part payment made thereof, the materials would be kept in custody of the Director & Head, CIPET CSTS, Amritsar for delivery to the bidder till receipt of bid amount in full.
9. All the labour charges towards loading, unloading and transportation charges etc. shall be borne by the successful bidders.
10. The successful bidders should make his own arrangement for custody and safeguard of the material as well transportation of the same. No claims and complaint what so ever, would be entertained on account of lifting and transportation.
11. The institution shall not be responsible for the loss, damage or any pilferages or any other unforeseen calamity and no claim on the account will be entertained.
12. Disputes of any kind arising out of the process of auction shall be settled by the Director & Head.
13. The under signed reserves the right to accept or reject any bid without assigning or communicating any reasons thereof.
14. Any bidder can submit Quotation separately for each items.
