Scope of Work includes the following:

Construction of False Ceiling at the new Campus of CIPET: CSTS-Agartala:

Construction of False Ceiling to be made with Gypsum board only as per the requirement of CIPET: CSTS-Agartala. Total area of measurement is approx **2000 sqft.** Bidders are advised to visit the site physically to get clear idea and exact requirement. The amount quoted by the bidders should be inclusive of construction of frames, other necessary material and includes labour charges. Technical specification of Gypsum board, Frame and other material is mentioned in **Annexure-1**.
