SPECIAL TERMS AND CONDITIONS / INSTRUCTIONS TO BIDDER

- 1. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. - 2. The purchaser shall not be liable for any expenses whatsoever incurred by the Tenderer in the preparation of the tender whether his tender is accepted or not even if the purchaser opts for complete withdrawal of invitation of Tender.
- Delivery at designated site is at the expense of the bidder and the exact address of Premises/location for Supply of Steel Cot and Bench with Desk will be mentioned in the Purchase Order / Work Order. CIPET will not be liable for any additional expenses incurred in this regard.
- 4. Bidder shall submit documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre qualification criteria.
- 5. Offer should be in two parts Viz., "TECHNICAL BID" and "FINANCIAL BID" and all bids must be submitted through the online portalwww.tenderwizard.com/CIPET.
- 6. Any Tender received after the last date for submission of E-Tenders prescribed in the tender, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
- 7. Tenders shall remain valid for 180 days after the date of E-Tender.
- 8. The work should be completed within 30 days time from the date of receipt of the Purchase Order / Work Order.
- 9. In case of non-receipt of supply & installation of equipment in all aspect as per the requirement within60 days from the date of issue of the Purchase Order / Work Order CIPET has right to charge Liquidated Damages @ 0.50% per week subject to maximum of 10% of the total Purchase Order / Work Order value.
- 10. The cost of tender document is Rs. 1,180/- Incl. of GST (Non-Refundable) and Tenderers are requested to pay the tender fees only through NFET/RTGS to the bank account details mentioned in SI. No. 4 (ii).of Salient information about the E-Tender.

- 14. TDS (Tax Deducted at Source) and GST TDS as applicable taxes will be deducted as per prevailing rules and regulations of the Government, as applicable.

10% payment will be released on final acceptance after Installation &commissioning at site and completion of training and submission of claim supported by the acceptance certificate issued by the Purchaser's Representative.
