### SPECIAL TERMS AND CONDITIONS / INSTRUCTIONS TO BIDDER

- 1. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. - 2. The purchaser shall not be liable for any expenses whatsoever incurred by the Tenderer in the preparation of the tender whether his tender is accepted or not even if the purchaser opts for complete withdrawal of invitation of Tender.
- 3. Bidder shall submit documentary evidence (signed by authorized signatory) proving that bidder fulfills the criteria as stated in Pre qualification criteria.
- 4. Offer should be in two parts Viz., "TECHNICAL BID" and "COMMERCIAL BID" and all bids must be submitted through offline mode
- 5. Any Tender received after the last date for submission of Tenders prescribed in the tender, will be rejected. Conditional tender will be summarily rejected without prejudice so bidders are advised to quote the price as per N.I.T. conditions only.
- 6. Tenders shall remain valid for 180 days after the date of Tender.
- 7. The Total Qty of Raw material approximately for RP-PP is 35Ton & RP-HDPE is 55 ton for the period of Six Months and the delivery Schedule of material should be as per Purchase Order issued from time to time
- 8. The rate contract is valid for a period of Six Months from date of issue of letter of intent
- 9. The cost of tender document is Rs. 1,180/- Incl. of GST (Non-Refundable) and Tenderers are requested to pay the tender fees only through NFET/RTGS to the bank account details mentioned in SI. No. 4 (b).of Salient information about the E-Tender.
- 10. The Tenderer shall pay Earnest Money Deposit of Rs.10,000/- in the form of online mode only. The tenders received without EMD shall be rejected. The Earnest Money of the unsuccessful Tenderers will be refunded after 15 days time from the completion of tender process.
- 11. EMD amount of successful bidder will be refunded after submission of performance security.



- 12. The earnest money deposit may be forfeited if:
  - a. The Tenderer withdraws his tender during the period of tender validity specified in the tender document.

- 13. TDS (Tax Deducted at Source) and GST TDS as applicable taxes will be deducted as per prevailing rules and regulations of the Government, as applicable.
- 14. The Tenderer shall complete the Tender Form and fill the appropriate Commercial Bid Furnished in the Tender Documents, indicating for the goods to be supplied, a brief description of the Goods, quantity and prices.
- 15. The Bidder shall indicate on the commercial Bid attached to these documents, the unit prices and Total Bid Prices of the goods, proposed to be supplied under the Contract.
- 16. Commercial Bid should be submitted in the prescribed format (Excel Format) given under price schedule of the Tender Document.
- 17. The rate quoted by the Tenderer should be firm and no escalation on any account whatsoever shall be paid for this work.
- 18. CIPET will notify the successful bidder & issue the letter of intent in writing by registered letter / e -mail to be confirmed that his tender has been accepted.
