The stitched uniforms shall be delivered at CIPET: IPT Chennai with the stipulated date as mentioned in the following para.

#### **C: ELIGIBILITY CONDITIONS:**

- (i) The bidder should have hands on experience of 2 years of stitching and supply of students uniforms to schools, colleges. It should be supported with proof of work order / purchase order.
- (ii) The bidder should submit copy of Annual Turnover duly certified by a Chartered account for the last 2 years. (Annual turnover should not be less than 10 lakhs in any of the 2 years)
- (iii) The bidder should submit photocopy of the registration certificate, MSME/ Start up, PAN, GST
- (iv) The bidder should have a registered office at the state of Tamil Nadu due to immediately attending the measurement, correction, alteration, etc.

- 6. Measurement shall be taken at CIPET: IPT Chennai on a date mutually agreed upon.
- 7. Stitched uniforms shall be delivered within 20 days from the date measurement taken and in any case, it should not exceed not more than 30 days from the date of issue of the work order.
- 8. In case of delay, liquidated damages at the rate 2% of the contract value for every week of delay shall be levied.
- 9. Taxes, levies, other duties shall be quoted separately or inclusive.
- 10. The rates quoted should remain valid for a minimum period of 06 months.
