

SALIENT FEATURES ABOUT E-TENDER AND GUIDELINES TO THE BIDDERS FOR E-TENDERING

1. **Mode of Submission:** ONLINE. No offline Tenders will be accepted.
2. **Availability of Tender Documents :** All bid formats (Technical & Commercial) are available in ONLINE at CIPET's e-Tender portal www.tenderwizard.com/CIPET & www.cipet.gov.in. The registered vendors can download the Bids from these websites.
3. **Who can participate for this e-Tender :** The vendors have to registered through www.tenderwizard.com/CIPET can only participate in this tender process.
4. **How to register by a vendor :**
The prospective bidders have to register with CIPET through the E-tender portal of CIPET at www.tenderwizard.com/CIPET by **Online Payment** as applicable to M/s. KEONICS LTD. On completion of the registration process, the bidders will be provided user ID and Password. After receipt of User ID and Password, Bidders can log on at our e-Tender portal for downloading & uploading tender documents.
