SCOPE OF WORK

GENERAL INSTRUCTIONS FOR TENDERERS

- 2. The Contractor has to provide GST & PAN number with Aadhar proof.
- 3. The agency / contractor shall give written undertaking that he accepts all the terms and conditions without alter.

- 5. CIPET reserves the right to cancel the all and/or any bids without assigning any reason.

ESSENTIAL REQUIREMENTS FOR THE TENDER

1. Minimum Eligibility of the Bidder

a) Service provider / Contractor should have minimum three years of experience in providing advertising services to the Departments / Ministries of the Government of India / PSUs / Corporates / etc. (Three copies of work orders received during each of the last two years should be enclosed).

2. Tender Prices

- a) The rates / prices should be quoted only in Indian Rupees (INR) in words as well as in figures.
- b) Taxes, if any, should be indicated separately.
- c) No additional charges will be paid other than the rates mentioned in the financial bid.

3. Submission of Tender

I) Sealing, Marking & Submission

- a) Envelope No.1 shall contain Technical Bid (Annexure I) with all the required supporting documents. A covering letter may also accompany the same.
- b) Envelope No.2 shall contain Financial Bid (Annexure II) in the prescribed format.
- c) All the above two envelopes shall be packed in a third Envelope (packed and marked) and addressed to CIPET: IPT, Kochi and must reach on or before the 14.02.2024 by 03.00 p.m.
- d) All the above envelopes shall bear the Name of the Work viz. "TENDER FOR ADVERTISING AGENCY".
