  - CIPET:PPEC, Plastics Park, Siju, Jhimani, Paradeep, Odisha 754141
2. The Tenderer is expected to examine all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required for the Tender Documents or submission of a Tender not substantially responsive to the Tender Documents in every respect will be at the Tenderer's risk and may result in rejection of the Tender.

5. **Supplier shall be responsible for any defect in shoe sole & quality of material at his own cost.**
6. Delivery should be completed within 30 days time.
7. **The item must be a fresh stock/manufactured in the year of 2021.**
8. Applicable taxes will be deducted as per prevailing rules and regulations of the Government.
9. The Bidder shall indicate on the Financial Bid attached to these documents, the unit prices and total Bid Prices of the goods, proposed to be supplied under the Contract.
10. **The suppliers shall be solely responsible for supplying the shoes in the given nos. & sizes and delivery at respective CIPET Centre's of Odisha as per the order.**
11. The Principal Director & Head, CIPET:CSTS, Bhubaneswar reserves the right to accept or reject any tender or all tenders at any time prior to award of contract without assigning any reasons whatsoever and no correspondence shall be entertained in this regard.
